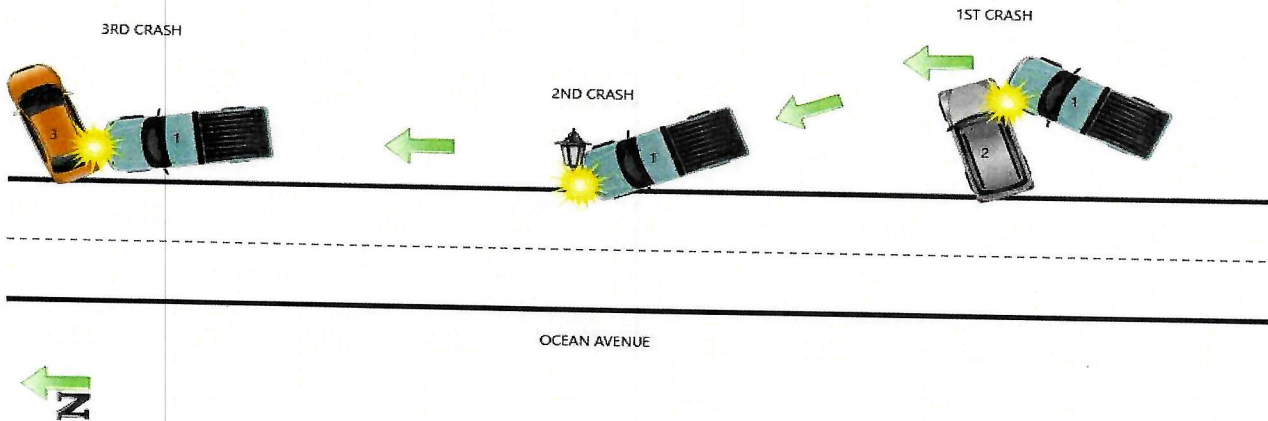

145 Crash Description/Narrative
