The following is the Point Pleasant Police Department's response to your email dated October 9, 2020 amending your OPRA request for certain records:

Request 1: Any incident reports/narratives, case summary reports/narrative, arrest reports, criminal complaints and/or summonses, including any follow-ups, pertaining to incident on 4/11/09 involving Brandon O'Shea and Michael Capanna. In your email dated 10/9/20, you stated, "As for item #3, I was a little confused by the answer of no records responsive to the request. In a previous OPRA request, you sent a summons from 4/11/2009 for Brandon K. O'Shea, which you identified as Special Complaint Summons 1524-SC-007227. That is the incident I am referring to. Upon arrival I spoke with the complainant, [REDACTED]. He stated he was upstairs in his bedroom and heard what sounded like some type of struggle outside of his window. [REDACTED] stated he did not look out his window to see what the problem was. [REDACTED]

§ 87(2)(b) stated he proceeded downstairs, opened the front door and ran outside. § 87(2)(b) stated he observed a female standing in the street just at the end of his property. § 87(2)(b) asked the female, identified as § 87(2)(b), what she was doing at his residence. § 87(2)(b) stated § 87(2)(b) told him she and her boyfriend Brandon O'Shea know that § 87(2)(b) has stolen property of theirs and they came over to talk to § 87(2)(b) about getting their property back. § 87(2)(b) told § 87(2)(b) coming to the house was not the way to handle the incident and suggested she leave. § 87(2)(b) stated § 87(2)(b) told him she was going to call the police. § 87(2)(b) stated he told her that would be a good idea, then told § 87(2)(b) he was going to § 87(2)(b). § 87(2)(b) stated he waited for a while and when the police did not show up, he took it upon himself to call the police.

I then spoke with [REDACTED] and asked what had occurred. [REDACTED] stated he had just arrived home. He stated he was going to go into the house and Brandon O'Shea came up from behind him and started punching him in the head and then slammed him up against the fence on the side of his residence. [REDACTED] stated he was able to get away from Brandon and went inside and locked the front door. At that point [REDACTED] ran down the stairs and went out the front door. I did observe several fresh red marks on the left side of [REDACTED] neck.

Brandon O'Shea and [REDACTED] arrived at police headquarters. [REDACTED] stated she and Brandon had been at Spano's Restaurant on Bridge Avenue. [REDACTED] stated she and Brandon had gotten word through some friends that [REDACTED] was involved in the burglary to their house the night before and decided to take a drive to [REDACTED] residence to talk to him. [REDACTED] stated they got close to [REDACTED] house and observed [REDACTED] get out of a car. [REDACTED] stated Brandon then approached [REDACTED] and started to get verbally loud with [REDACTED] asking why he was at his residence. [REDACTED] stated [REDACTED] laughed at Brandon, then flicked a lit cigarette at Brandon, but did not hit him with it. She stated it appeared [REDACTED] was going to pick something up off the ground and throw it at Brandon, so Brandon pushed [REDACTED] into a fence on the side of [REDACTED] property. [REDACTED] stated after that, Brandon left and walked down the street.

[REDACTED] stated she waited around for a few minutes. [REDACTED]

[REDACTED] She stated [REDACTED] asked why she was on his property. She told him she and her boyfriend wanted to speak with [REDACTED] about stolen property he had of theirs. [REDACTED] also gave a voluntary taped statement which was also tape recorded by Det. Joseph Hynes.

Next, I spoke with Brandon O'Shea regarding the incident. Brandon stated he and his girlfriend, [REDACTED] were out to dinner at Spano's on Bridge Avenue. Brandon stated he did speak with some friends that told him [REDACTED] was possibly involved in the burglary to his residence. Brandon stated he and [REDACTED] decided to take a drive to [REDACTED] house to speak with him. Brandon stated when they got to Johnson Avenue, he observed [REDACTED] getting out of a vehicle. Brandon stated he approached [REDACTED] and started cursing and swearing at him asking why he broke into his residence. Brandon stated [REDACTED] started laughing at him and flicked a lit cigarette at him. Brandon stated he thought [REDACTED] was going to pick up a rock and throw it at him so he pushed [REDACTED] in the head forcing him to hit a fence in his yard. Brandon stated [REDACTED] got up and went inside his residence. Brandon stated at that time he left and walked down Johnson Avenue.

Lastly, I advised Brandon O'Shea he was being charged with simple assault on [REDACTED] for causing visible signs of injury to him. He was released on a short form Boro summons charged with 2C:12-1a.
