## Narrative

### Toms River Police Department Investigation Narrative

On 10/14/19 at approximately 2146 hours, I, Ptl. M. Brown, was dispatched to the District One lobby, 255 Oak Ave, for a harassment report. Upon arrival I met with reporting person [REDACTED] who related the following.

On the date of this report, while in class at Ocean County College, [REDACTED] received several text messages from Denette Pasqualini and her [REDACTED] via a text message "group text". Also in the "group text" was [REDACTED] friend, Alyssa Pasqualini, who did not participate in the conversation. In the "group text", Denette Pasqualini accused [REDACTED] of calling her a "bitch" as well as making several other accusations. [REDACTED] stated that she has not had contact with Denette Pasqualini or her [REDACTED] in several months and is unsure of why Denette Pasqualini would be making these accusations. [REDACTED] advised that Denette Pasqualini and her [REDACTED] are prone to violence and she found the text messages harassing in nature. A screen capture of the text messages are attached to this report under the "manage files" tab. [REDACTED] date of birth was unknown at the time of this report, therefore she could not be listed as an involved person under the "involvement" tab.

[REDACTED] wished for this incident to be documented and was advised of complaint procedures. It should be noted that [REDACTED] originally reported this incident to the Lacey Township Police department because all parties involved live in Lacey Township. However, Lacey Township advised [REDACTED] that because she received the text messages while in Toms River, the incident should be reported there.
