On 10/18/2019 at 1926 hours I responded to District One for a lobby report. I spoke with the victim, [REDACTED] who stated she was being harassed by an acquaintance, Billy Harms. She stated the following:

Recently [REDACTED] had met an individual 10/12/2019 at a meeting held on the OCC property. She exchanged phone numbers and became friends on several different social media platforms. After they communicated for several days [REDACTED] became alarmed by Billy's behavior. She claimed he messaged her via SnapChat and became angered when she didn't respond. She stated he had been showing up to [REDACTED] club meetings and acted weird by following her around then waited in his car for her to leave.

Due to this bizarre behavior [REDACTED] was uncomfortable with his presence. She has blocked him on social media and notified the instructor of the program. William is believed to have an address in Camden County and work at V&F Auto Body of Keyport per [REDACTED]. She was advised of the complaint procedure.
