On Monday January 5th 2015 at approximate 0100 hours I S Reyes unit 342 was dispatched to an MVA with injury in the area of 777 Joe Parker Road. Upon my arrival, I observed a black male (later determined as Joshua D Wilson) sitting on the side of the road. His facial, head area was covered in blood. He stated to me that he lost control of his vehicle and crashed. Myself and Officer W Allen unit 287 rendered first aid by applying several pieces of gauze to the facial area of Wilson in order to reduce the bleeding. EMS arrived on scene and transported Wilson to JSMC.

Officer D Silberstein unit 312 from the Traffic and Safety unit was contacted and advised that Wilson was ejected from the vehicle. Silberstein arrived on scene to take photographs on this accident. Silberstein then advised me to proceed to JSMC to see if the medical staff had withdrawn blood from Wilson. I then proceeded to JSMC at approximately 0200 hours and spoke to Kathleen Cala (Trauma Nurse) who stated to me that blood was withdrawn from Wilson and that it was going to be preserved in their blood lab's department. P.O. Silberstein was advised of this information. Nothing else to report at this time.
