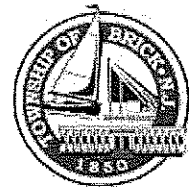

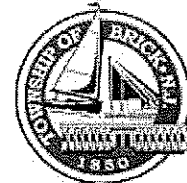

I also asked to have the kids everyday this week I was allowed to have the kids Monday Tuesday Wednesday but not Thursday or Friday. When I did have the kids I was only allowed an hour to an hour and a half with them. I am allowed to have the kids ~~parent~~ unsupervised and my wife is supervised by court order which is why I am dealing with my sister-in-law

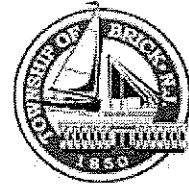

On 02/07/19 at approx. 1648 hrs. Ptl. Haugh #217 and I responded to 11 Holly Road, Brick, NJ 08723 in reference to a welfare check for two (2) children.

Dispatch advised that the caller/complainant (Katherine Hall) advised that her two Daughters [REDACTED] were picked up by her husband (Ryan Hall) from the Honey tree daycare on Rt. 88 in Brick today. Katherine Hall further stated that she has a TRO against Ryan and he did not have permission to pickup the kids today from daycare.

Upon responding to 11 Holly Road, Ptl. Haugh and I located Ryan and the two (2) children at home. Upon speaking with Ryan he produced the TRO against him (FV-15-001168-19) which he stated provided him with unsupervised visits with his children as long as his sister in law (Christina McNabb) is aware. Ryan Hall then showed me a text that he sent McNabb today asking to pick the children up from daycare. McNabb originally replied that this would be OK and then a few minutes later texted that it might not be a good idea, however did not advise Ryan Hall not to pick them up. Ryan stated that he responded to the daycare and drove his children to his residence. Ryan Hall stated that he has been separated from his wife Katherine since approx. 2016 and several TRO's have been issued against him but were never made final.

While we were at the residence Katherine Hall responded with her sister Christina McNabb to 11 Holly Road and took custody of the children which Ryan agreed with.

Both parties have a court date for Ocean County Superior court on February 26th and stated that at that time they would attempt to negotiate a better solution for parenting and visitation with the children.

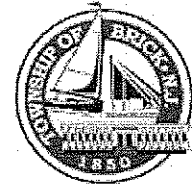
The current TRO states that the defendant (Ryan Hall) is permitted unsupervised parenting time arranged through plaintiff's sister (Christina McNabb) and it did not appear that Ryan Hall violated the current TRO.

While speaking with Katherine Hall when she responded to take custody of her children she stated to me that both parties were at DCP&P today for appointment and she

had not agreed to have Ryan pickup the children today because she already had plans after daycare with them which her sister was apparently unaware of when she responded back to Ryan via text message.

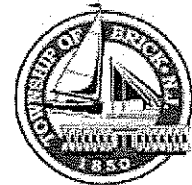
On 2/1/19 Plt. Zimmerer 272 and I responded to 11 Holly Rd for a keep the peace.
