Upon my arrival I met with [REDACTED] and his son [REDACTED]. [REDACTED] informed me that while [REDACTED] was on his way own from school (Memorial Middle School) he was approached by [REDACTED] who then hit [REDACTED] repeatedly and then removed [REDACTED]'s sneakers and continued to hit him. It should be noted that [REDACTED] is autistic and was more comfortable having his father communicate for him. There was noticeable swelling on [REDACTED]'s left eye from the assault. [REDACTED] states that there were multiple kids who witnessed the assault along with the school crossing guard assigned to the Memorial Middle school post.

Detective Eleshewich was called and advised of the situation at hand.

Mrs. Schwindt also informed me that the school has been documenting ongoing issues involving [REDACTED] harassing [REDACTED]. On 5/6/22 I notified [REDACTED]'s parents, [REDACTED] that evidence shows [REDACTED] was the aggressor not [REDACTED]. I also informed them that the school will be handling this incident and it is not a criminal matter. I burned a copy of the video and attached it to property.

Narrative

On the above date and time, while on duty in RMP 910, detailed to FLPD HQ on a walk in reporting a juvenile issue.

Upon arrival, I met with the complainant, [REDACTED], who stated that her son [REDACTED] was involved in an issue today at school. [REDACTED] stated that today while at school, Memorial Middle School, [REDACTED] was pushed by [REDACTED] while walking in the halls. [REDACTED] attempted to push him back, but failed to do so. Later in the day, while walking to Period 8, [REDACTED] was walking up a stair case and either [REDACTED] or [REDACTED] then shoved their finger or something similar into [REDACTED]'s anus. [REDACTED] stated it was inserted enough that both his pants and boxers were inserted too. [REDACTED] attempted to defend himself again by kicking them away, but failed.

I advised [REDACTED] to contact the school in the morning and advise the principal of the incident. I advised a report would be filed and to have [REDACTED] stay away from [REDACTED] and [REDACTED] in the future.

On 3/8/22 I responded to Memorial Middle School and met with SRO Feola about this incident. SRO Feola retrieved video which showed [REDACTED] walking up the stairs of stairwell #3 at 1326 hrs. Behind [REDACTED] was [REDACTED]. In the video you can see [REDACTED] lunge towards [REDACTED]'s buttocks with his left hand.

On 3/8/22 at 1515 hrs. [REDACTED] and his mother, [REDACTED] responded to FLPD to partake in an interview. Det. Buitron and I conducted the interview and recorded it. [REDACTED] initially stated that [REDACTED] had inserted his finger through his clothing and into his anus. I asked [REDACTED] if he had any injury or discomfort and he stated no. I explained to [REDACTED] of the difference between anal penetration and the sliding between the cheeks of the buttocks. I inquired further as to whether it was a wedgie type feeling between his buttocks or actual insertion into his anus. [REDACTED] then informed me that it could have been either and was unsure.

I contacted BCPO and informed Det. Castellanos of the circumstances of this case. After briefing him, the detective found that this case fell under the statute of Criminal Sexual Contact 2C:14-3 4th degree. Det. Castellanos also stated that BCPO would not be conducting an interview of the victim. [REDACTED] and Lindsay were both informed that I will be conducting a stationhouse adjustment with [REDACTED].

I contacted the Division of Family Guidance and informed Sara D'Eletto of the circumstances surrounding this case. Ms. D'Eletto informed me that they will enroll [REDACTED] into a specialized diversion program that will address his behavior.

On 3/10/22 at 1515 hrs. [REDACTED] responded to FLPD with his father, [REDACTED] to participate in a stationhouse adjustment. [REDACTED] agreed to the provisions of the adjustment which included completing a diversion program with the Division of Family Guidance. I sent a copy of the adjustment to family guidance to enroll [REDACTED]. I burned a copy of the interview as well as the incident and attached them to property. A Handle With Care form was sent to Memorial School on behalf of [REDACTED].

On 1/20/22 at approx. 1300 hrs. Det/Lt Leitman and I responded to Memorial Middle School to speak with Vice Principal Tarquinio about a juvenile matter. Upon arrival Mr. Tarquinio stated that he received an e-mail on 1/18/22 from [REDACTED], the parent of [REDACTED], (victim). The e-mail stated that [REDACTED] (actor) had taken a screen shot of [REDACTED]'s private area during a face time phone call. [REDACTED] was on the phone with [REDACTED] while preparing to take a shower. [REDACTED] was unaware that the screen was flipped around which made him visible to [REDACTED]. [REDACTED] took a screen shot of [REDACTED] and sent it to juveniles, [REDACTED]; and [REDACTED].

Mr. Tarquino informed me that [REDACTED] had already spoken to the parents of the juveniles. Mr. Tarquinio also spoke to the parents and juveniles and was ensured that the photo had been deleted by all involved parties.

I spoke to [REDACTED]'s parents [REDACTED] and [REDACTED]. Both [REDACTED] and [REDACTED] were satisfied with the school's response as well as the conversations they had with the parents of the juveniles. They want no police involvement at this time.

Narrative

On December 14, 2021 I was assigned to RMP 910 in post 1, when a walk in report of an assault came into HQ.

As I spoke to [REDACTED], he related that his son [REDACTED] was assaulted after school today by another student by named [REDACTED]. His son told him that [REDACTED] started pushing him then punched him, while [REDACTED]'s mother hold him and drag him as her son [REDACTED] continued to hit him. Several kids witness the incident and begun to yell at [REDACTED]'s mother to let [REDACTED] go cause she can't put her hands on a minor. Once [REDACTED] managed to get free he ran home and immediately called [REDACTED].

[REDACTED] stated that on Wednesday Nov. 3rd approximately 16:00 Hrs he was hanging around after school and he began to video on his phone [REDACTED] waving a black toy gun and also in possession of a toy switch blade. [REDACTED] was asking why [REDACTED] always calls people the N-word including calling him the N-Word. Also present and seen on video is student [REDACTED] who stated to Mr. Tarquinio that he received a call from [REDACTED] on Wednesday that he was having a problem and for him to bring the BB gun to Memorial. [REDACTED] stated that he is the owner of the gun and that he brought the gun to the school grounds at [REDACTED] request and that [REDACTED] took it out of his backpack. [REDACTED] stated to Mr. Tarquinio that he was having problems with several people which he did not name and that he called [REDACTED] to bring him the BB gun to Memorial Pool which [REDACTED] did. In the videos [REDACTED] is spinning the gun around his index finger and opening and closing the knife. In the videos a party asks [REDACTED] why he uses the "N-Word". [REDACTED] denied using the word and continued playing with the items. At no time does [REDACTED] threaten anyone or make a threatening gesture in the videos.

On 11/11/21 Det. Lugo and I responded to [REDACTED] to speak with [REDACTED] and his mother, [REDACTED]. Once at the residence [REDACTED] turned over the knife and the gun. The gun was confirmed to be an air soft and the knife is a toy. [REDACTED] informed Det. Lugo and I that he brought both items down to Memorial School so [REDACTED] could play with them.

On 11/11/21 at approx 1600 hrs. [REDACTED] responded to headquarters with his parents, [REDACTED]. [REDACTED] stated that he was playing at Memorial with his friend "[REDACTED]". [REDACTED] informed me that [REDACTED] thought he heard [REDACTED] say something that ended in "ugh" from across the field. Once the Zoom virtual class started he observed two parties named [REDACTED] logged into the class. Mr. Cohen informed me that he asked a question only a member of the class would know the answer to. The [REDACTED] that was unable to answer the question was then removed from the class by Mr. Cohen. Shortly after a party named "[REDACTED]" entered the Zoom class. In the Zoom chat [REDACTED] stated, "[REDACTED] u ugly fat ass bitch you ugly asf" and "I'll kill you and ur family ugly whore". Mr. Cohen observed these statements and removed [REDACTED] from the virtual class. Mr. Cohen informed me that there is a member of the class named [REDACTED] but he was physically in the classroom and had no access to a digital device.

I spoke to Fair Lawn Board of Education IT supervisor Radhmes Tatis. Mr. Tatis was able to provide the names and IP addresses of the parties that logged into that class. On December 15, 2021, I was assigned to Thomas Jefferson Middle School as the School Resource Officer.

I was notified by Vice Principal Jenna Renna that she needed to speak with me regarding something that a student overheard in the hallway yesterday. Mrs. Renna said that a 5th grade student, [REDACTED], advised her that while she was walking to class yesterday, she heard a conversation between students indicating they were not coming to school this Friday. She went on to say that [REDACTED] heard the students say "I'm not coming to school Friday because someone is going to shoot up all the U.S. schools." [REDACTED] could not identify who made the statement, nor could she identify the voice as to whether or not it was a male or female who was speaking.

Mrs. Renna introduced [REDACTED] to me and we reviewed the school video from yesterday in the location of where she said she heard the statements. [REDACTED] was located on video but could not identify who made the statement. She was fairly distant from other students as she was walking to her next class. [REDACTED] believed the conversation was coming from behind her. Ms. Renna was not able to determine if the conversation actually occurred.

I also spoke with head of District Security, Robert Licamara. Robert told me that he spoke with William Stallone from the Bergen County Prosecutor's Office Intel Unit. William told Robert that a TikTok is going around that appears to have originated in Texas. It refers to shootings and bomb threats on Friday at schools. The threats on TikTok are not credible to our area and there are no credible reports regarding any threats in Fair Lawn. It is possible [REDACTED] may have heard students talking about this TikTok post.

I advised Mrs. Renna and Vice Principal Grubman that I would take a police report so patrol is aware of the incident. Mrs. Renna also has advised Principal Weaver regarding this incident.

On December 6, 2021 I was assigned to Thomas Jefferson Middle School as the School Resource Officer.

Principal Michael Weaver approached me and asked me to review an email he received this morning. The email was signed by Dmitry Kraminkin who states he lives in Belarus and can't come here due to a visa barrier. Dmitry claims to have a daughter named [REDACTED] whom he has not seen in four years. He states [REDACTED] is a student and she attends this school. Dmitry cites [REDACTED]'s mother claims "my uselessness for life in USA" as her reason for not communicating with him. He asks that a teacher writes to him to tell him something about his daughter. Dmitry states, "I beg you to tell me something about her". "How does she study?" "Can one of her teacher write to me - what kind of person is she?"

I asked headquarters to run Dmitry for Domestic Violence restraining orders. No DV orders were located. No other information about him was located in the in house file system.

I advised Mr. Weaver that he should make contact with [REDACTED]'s mother, Katsiaryna Mauchanova, to let her know he received this email. She can then decide if contact should be made with Dmitry or she can advise the school otherwise. It's not truly known at this time who actually sent the email.

The Board of Education does have a Dzity Kzaminkin listed as the father in the primary contact files. The spelling of Dmitry in the Fair Lawn Board of Education files is slightly different than the one in the email. Dmitry also spells his last name slightly different than [REDACTED]'s, he adds an "a" to her last name.

I met with the teacher who took the item, Mariia Cosmi. Ms. Cosmi said that while in class a student, [REDACTED], said out loud several times that he accidentally brought a BB gun to school. Ms. Cosmi said she asked [REDACTED] to come to the front of the room and place the item from his pants pocket into a desk drawer. The item she described was bright orange in color. She was not capable of telling me what type of gun it was.

Ms. Cosmi and I went to the classroom, 224, and retrieved the item from the desk drawer. It was identified as a small bright orange toy cap gun with caps in it. The toy gun fit in the palm of my hand. I took possession of the item and notified Mr. Weaver, the Principal, and Mr. Grubman the Vice Principal. Mr. Grubman took possession of the item and advised he would handle discipline within the school.

A short time later [REDACTED]'s father, [REDACTED], arrived at school and took him from the premises.

Narrative

On Thursday, October 7, 2021 while assigned to Warren Point Elementary School as the School Resource Officer, I was summoned by the schools Principal Sue Gons. Mrs. Gons explained that she received a telephone call from Danielle Treboski who is the mother of [REDACTED], a Kingdegarden student at the school. Mrs. Gons said she had a telephonic conversation with Mrs. Treboski who requested that the school not release [REDACTED] to her father, William Tirri. Mrs. Gons stated that Mrs. Treboski had arranged for their daughter to stay in an after school program and had text this request to Mr. Tirri but believed he would not listen to her request. Mrs. Gons said that during her conversation with Mrs. Treboski she inquired if there was a current custody agreement or court order. Mrs. Gons said that Mrs. Treboski said there was only a verbal agreement between the two parents.

At school dismissal Mr. Tirri was present to pick up his daughter and was met by the Principal. I also was summoned by the principal to observe. When I arrived Mr. Tirri was on speaker phone with his lawyer. I spoke with Mr. Tirri who stated to me that he is the father of [REDACTED] but is not married to Danielle Treboski. Mr. Tirri explained that he and Mrs. Treboski have a custody hearing date on October 12, 2021 to iron out dates and times of custody and visitation. He claimed that his arrangement with Mrs. Treboski is that he picks his daughter up on Tuesday's and Thursday's. He also said that there are no current court orders spelling out times and dates of custody.

Principal Gons and I contacted Mrs. Treboski by telephone and re-verified that there were no current orders spelling out custody or visitation preventing Mr. Tirri from taking his daughter. Mrs. Treboski agreed that there was no current order and they were scheduled for Oct 12, 2021 custody hearing. Mrs. Treboski disagreed with Mr. Tirri's statement that he picks up his daughter on Tuesday's and Thursday. I explained that we could not legally prevent Mr. Tirri from picking up his daughter from school until there was an order spelling out dates of custody.

Mr. Tirri picked up his daughter and said that he was taking her to his residence in Parsippany, NJ.

On 10/29/21 at 1336 hrs. I responded to Radburn School on a report of possible sexual activity between students. Upon arrival I was met by school principal Jill Lindsay, along with teachers Annie Moylam and Stephanie Domnitz. Ms. Moylam and Ms. Domnitz stated that on 10/29/21 at approx. 1200 hrs. they responded to the residence of student [REDACTED] to drop off fundraising material. Once at the residence [REDACTED]'s mother, [REDACTED] informed them that [REDACTED] had confided in her the prior evening that she has engaged in sexual activity with another student over the past few months. Ms. Macaluso stated that [REDACTED] has been having play dates with another student, [REDACTED] since approx April 2021 (both juveniles are [REDACTED] years old). Ms. Macaluso informed the teachers that while at [REDACTED]'s residence, she will remove her pants and also [REDACTED]. On various occasions [REDACTED] will touch her own vagina as well as [REDACTED]'s as well as pressing their vaginas together. On one occasion [REDACTED] used a Q-tip to wipe the exterior of [REDACTED]'s vagina.

Immediately after leaving the [REDACTED] residence Ms. Domnitz and Ms. Moylam reported the incident to school principal Jill Lindsay. Prior to my arrival Ms. Lindsay reported this incident to DCP&P screener Latoya #1589. After being given the circumstances of this case Latoya informed Ms. Lindsay that this incident did not meet the criteria for an investigation by her agency.

I contacted the Bergen County Prosecutor's Office Special Victim's Unit and spoke to Det. Trignano. I informed Det. Trignano of the circumstances surrounding this case and he informed me that he does not see any criminality in this case. (See BCP 21-01315).

I called DCP&P and spoke to Jason #1503. I informed Jason of the circumstances surrounding this case and he stated that he was aware of it. Jason also stated that this case did not meet their criteria and he stated that I should speak with Perform Care's Mobile Response Team. Jason did inform me that a DCP&P incident report would be generated.

I spoke to Jamie #1207002 at Perform Care and informed her of the circumstances around this case. Jamie stated that the services they provide would be available for [REDACTED] if her parents choose to contact them. Jamie also informed me that she would be contacting DCP&P in an attempt to have them open an official case for this incident.

I spoke to [REDACTED] and informed her of my conversations with DCP&P and Perform Care. I sent a Handle With Care form to Ms. Lindsay at Radburn School for both [REDACTED] and [REDACTED].

Narrative

On Tuesday February 1, 2022 at approximately 1445 hours, I was notified by the Fair Lawn High School Administration of a juvenile issue involving nude images. I was assigned to Fair Lawn High School (14-00 Berdan Ave) at the time and utilized RMP SR1.

I was requested in my office and spoke with FLHS Assistant Principal Vincent Aiello, who informed me that while he was speaking with [REDACTED] (juvenile student), he was made aware of nude images of another juvenile, [REDACTED]. Aiello explained that he was speaking to [REDACTED] about illegal gambling activity involving him and [REDACTED] and that in the course of the discussion, the nude images of [REDACTED] were discovered. Aiello stated that the gambling issue was brought to his attention by [REDACTED]'s mother, [REDACTED] and that while he was looking at [REDACTED]'s text messages, he discovered requests from [REDACTED] asking for nude images again. Aiello stated that [REDACTED] stated that [REDACTED] sent him that photos recently and that he did not share them with anyone else. [REDACTED] stated that there were around nineteen compromising images sent to him by and of [REDACTED]. [REDACTED] sent to images to my e-mail and deleted them from his phone and e-mail, stating that there were no more that he is aware of. Once the images were given into my custody, they were transferred to a disk and entered into the Spillman System. 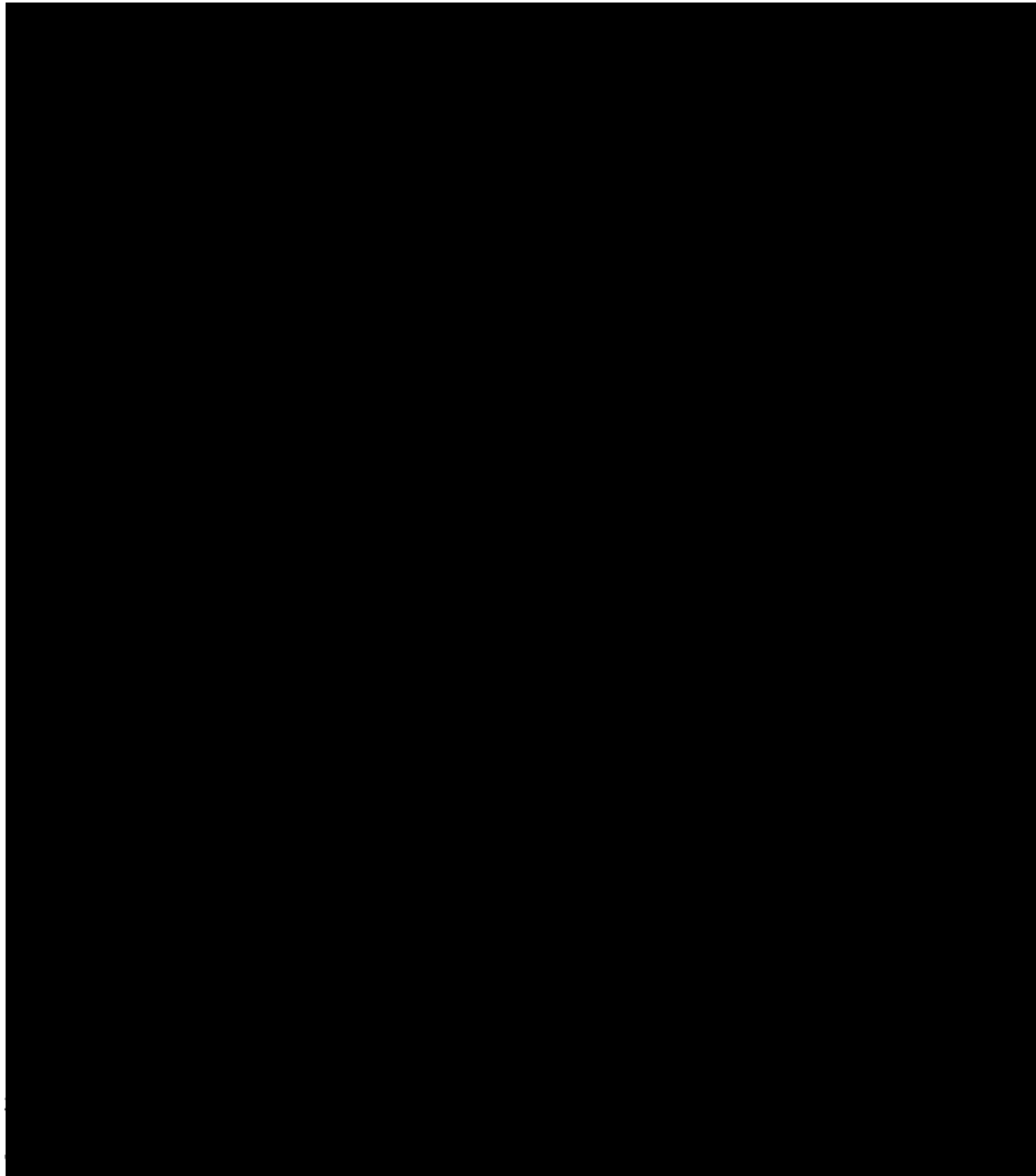
