Narrative:

I guided [REDACTED] off the bus, where Sgt. S. Ramirez #310 was able to assist help me calm [REDACTED] down. Detective A. Ramirez #350 arrived on scene to assist.

I was able to obtain [REDACTED]'s emergency contact information from the bus driver and contact his mother, Ms. Deiree Reiner. I explained to Ms. Reiner the current situation and asked her for her permission to transport [REDACTED] to his residence at [REDACTED] due to the possibility of leaving [REDACTED] in the bus and him having another altercation with students on the bus. Ms. Reiner agreed and stated "yes." Officer N. Ruscigno #356 and Officer J. Guzman #379 arrived on scene to assist with the transport.

I transported [REDACTED] in vehicle #15 to [REDACTED] with Officer N. Ruscigno #356 and Officer Guzman #379 following in vehicle #19. Custody of [REDACTED] was turned over to his father, Mr. Gerald Reiner.
