Please note that redactions have been made to remove personal telephone numbers, driver's license numbers, and dates of birth from the police in order to protect the individuals' reasonable expectation of privacy pursuant to N.J.S.A. 47:1A-1 (providing that "a public agency has a responsibility and an obligation to safeguard from public access a citizen's personal information with which it has been entrusted when disclosure thereof would violate the citizen's reasonable expectation of privacy"); See also N.J.S.A. 47:1A-1.1 (exempting that portion of any document which discloses the "unlisted telephone number or driver's license number of any person" from the definition of a "government record"). N.J.S.A. 47:1A-9(a)-(b) upholds exemptions contained in other State or federal statutes and regulations, Executive Orders of the Governor, Rules of Court, Constitution of this State, or judicial case law. Executive Order No. 26 (McGreevey 2002) (4) requires the redaction of "Information relating to medical, psychiatric or psychological history, diagnosis, treatment or evaluation.

On Oct 23, 2019 at 2153hrs [REDACTED] came to police headquarters to make a report of harassment against Gretchen Hickey, John Roman and John Kaczor. Brown states that earlier today he was made aware of a Facebook post in which Gretchen Hickey made comments connecting him (Brown) to a political situation in Dover, NJ. [REDACTED] states Hickey made accusations that Linden Mayor Derek Armstead made a campaign contribution to a mayoral candidate in Dover, NJ because [REDACTED]. This post was on Hickey's page.

On Sunday Oct 20, 2019 Brown states John Roman and John Kaczor both made allegations via Facebook that [REDACTED] had a homeless woman arrested or removed from the front of Linden City Hall. These posts were on Roman's and Kaczor's respective pages. I asked [REDACTED] if Hickey, Roman or Kaczor contacted him directly or had anyone else contact him and he said they did not; a friend of [REDACTED] took screenshots of their pages and sent them to him so he was aware of it. [REDACTED] cell phone was dead at the time of the report so he was sent an evidence.com citizen link so he could upload the screenshots at a later time.

On 10/20/2019 at approximately 0744 hours, while in marked unit 702, I was dispatched to the front of city hall (301 N. Wood Ave) on a report of Barbara Winkler vomiting.

Upon arrival, Linden Fire Department ambulance L-51 was on scene, attempting to treat Winkler [redacted]. Winkler was refusing all attempts of assistance. The caller who was identified as, Bruce Creanzo, claimed to be a medic in the past, [redacted] b7C b7D

Observations on scene of Winkler during 1st contact:

- Empty beer cans in a bag were observed by her foot.

Multiple officers including Sgt. Melchionna pleaded with Winkler to seek assistance for her well being. Winkler remained uncooperative and demanded we leave her alone. Linden Fire Department ambulance squad L-51 pleaded with her to get medical attention with negative results. Finally,

Creanzo pleaded with Winkler to get medical attention with negative results. Creanzo stated that he will assist Winkler with tidying up her sitting area. We cleared the scene without further incident.

At 0912 hours, officers were dispatched back to the front of city hall on a report of a fight in progress (case #19050120). Creanzo had a verbal dispute over Winkler's belongings with John Kaczor aka "Kip", which ultimately turned physical. A witness identified as, Donald Grossi, stated that Kaczor and Creanzo only pushed each other and nothing further happened. Creanzo stated that he was cleaning up for Winkler and Kaczor approached him from behind to tell him to get away from her. Kaczor stated that it was not necessary for Creanzo to place Winkler's belongings in the garbage receptacles and he confronted him. Kaczor stated that Creanzo presented a knife wrapped in black tape to scare him then Creanzo allegedly threw it in the grass prior to police arrival. The item in question was located which was deemed to be a screwdriver wrapped in black tape, and it was secured for safe keeping to prevent anything further. Creanzo stated that he used the item to break up the items that he threw away, he did not threaten Kaczor. After explaining complaint procedures to both Kaczor and Creanzo, they both stated that they were not interested in filing a complaint and just wanted to make sure Winkler was ok. Before leaving the scene, Kaczor pleaded with Winkler to get medical attention, to which again she refused and requested to be left alone. The item in question was tagged for safe keeping and placed into locker #24, witnessed by Sgt. Melchionna.

2nd Check of Winkler's welfare:

- Before standing up, a trail of liquid was coming from Winkler's clothes, I believed the liquid to be urine seeing how she did not spill anything.

- A heavy smell of Urine was emanating off of Winkler's person.

A psych screener from Trinitas Hospital identified as, Silvana Gomez, responded to the city hall at approximately 1100 hours (refer to case #19050126). Ms. Gomez spoke to Winkler for several minutes and determined that Winkler [REDACTED]

[REDACTED]. At this point an ambulance was requested and Linden Fire Department L-52 responded to the scene for transport. Winkler was advised of the situation and she resisted verbally. After placing proper Hazard uniforms on, Winkler was escorted into ambulance L-52 without force. Winkler was successfully transported to Trinitas Hospital without incident. [REDACTED]

[REDACTED]. Before clearing from the hospital, Winkler specifically requested that the bag she left on the couch along with her umbrella be secured for safe keeping.

Once back in town, I stood by for Linden Department of Public Works to arrive to dispose of the over filling garbage receptacles in front of city hall. DPW arrived on scene at approximately 1315 hours and removed everything out of the garbage receptacles as requested. The couch in question was also removed due to a heavy smell of urination, a clear infestation of bed bugs, and being deemed a public health hazard. The personal items that Winkler requested be secured for her, were brought to the DPW work site (700 Lower Road) for safe keeping per DPW supervisor Frank Dann.

- Screening Outreach Request for Police Transport and Supervision form on file.
- Councilman Roman and Brown were on scene during the last encounter with Winkler before the transport and they were advised of the situation.
- Burn Request on file for all incidents involving Winkler on today's date.

On the above date/time [REDACTED] came to police HQ to make a report of possible cyber harassment. [REDACTED] showed me screenshots of social media posts made by several Facebook accounts bearing the name "John Kaczor" and "Kip Kaczor". [REDACTED] believes these accounts belong to

a John Kaczor, an individual with whom he has had issues with in the past. These posts contained different photos with hash tags (notations) referring to Brown. Some of the posts had photoshopped images of [REDACTED] face while others had various other people or pictures with comments referencing [REDACTED] his capacity as a councilman. One post in particular had a hash tag of " #killshot ", which [REDACTED] believes is a threat towards him. [REDACTED] believes Kaczor's actions are indicative of someone with a bipolar disorder and he fears for his safety and that of his children. I asked [REDACTED] if the "Kaczor" account sent him the photos or made contact with him and he said no, someone else screenshots the posts and sends them to him so he's aware of it. [REDACTED] has these photos/posts on his cellphone so I sent him an evidence.com citizen upload link so he could forward all the screenshots for the case file. [REDACTED] stated most of the photos/posts are from August 2019.

I contacted on-call Union County A/P Estrella Lopez and informed her of the situation. At this time, based on the information available, A/P Lopez declined to authorize any charges. [REDACTED] was advised that an incident report would be completed and reviewed by the investigative division.

The basis of the citizens claims were Facebook posts on Kaczor's account claiming he had voted at several different polling locations under the alias' Axel Foley, Fred Bohuk, and Billy Presler. In addition, Mislan reported that Kaczor posted a photograph taken from inside a voting booth and she believed this was in violation of State statute.

Mislan inquired with the poll workers at the JTG Center and they advised her that Kaczor had not made any attempt to vote at this location. Mislan had not received reports from any other citizens her poll workers that Kaczor had voted at any other location.

Photos of the Facebook posts were provided and I uploaded them to Evidence.com.

On February 28, 2019 at approximately 1725 hours Ofc Pozsonyi and myself were at Headquarters when [REDACTED] responded to file a report of harassment.

[REDACTED] explained that for over a year an individual by the name of John Kaczor has been harassing her and her family on Facebook. On February 18, 2019 Kaczor posted two pictures: 1. a photo of [REDACTED]'s husband, Derek Armstead (mayor of Linden), with his face in a grey hoodie pointing a gun. 2. a picture of [REDACTED]'s mother in law, Lisa Ormon, with blood splatter coming from her head and a caption explaining that Ormon and Armstead would like that after they were beaten.

[REDACTED] explained that recently she has been repeatedly tagged in these photos and that it is making her and her family scared for their safety. She also explained that whenever she sees Kaczor in a public place she walks away from him. In response, Kaczor has posted on Facebook that she does not have to avoid him in public. [REDACTED] showed us two accounts presumably used by Kaczor, "John Kaczor" and "Kip Kaczor".

[REDACTED] was provided a link to evidence.com to upload screenshots of the comments. She was advised of complaint procedures.

[REDACTED] stated her husband Derek Armstead has already made a police report concerning these posts, however she also feels victimized and wanted to make her own report.

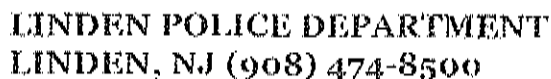

I then once again Identified myself as a Linden Police Officer to Mr. Kaczor at which time he tried to run. I then grabbed Mr Kaczor by the back of his sweat shirt, Mr. Kaczor then slipped on the grass and fell onto the side walk. At this point, I once again Identified my self to Mr. Kaczor and stated that he was under arrest for assault in which time he said " Go Fuck Yourself " and started to resist, by flailing his arms and twisting his body to avoid being handcuffed.

Once I had him on the ground with his face down, he was advised several times to stop resisting. As he failed to comply, I then, to gain control of Mr. Kaczor, had to use compliance hold (Arm Bar) and then complied and was handcuffed. At this time other Units arrived and assisted me patting down Mr. Kaczor for weapons and contraband with negative results and was placed in Unit 703, where he was transported to Linden Headquarters without incident.

Once at Headquarters Mr. Kaczor was booked and charged with the following:

While on patrol in marked unit # 709 I was notified by Ofc. Mitros of three individuals vandalizing the property on the 100 block of S. Wood Ave. Ofc. Mitros described the actors as 2 W/M, one wearing a white muscle shirt and the other wearing a dark blue hat and dark shirt. Accompanying the actors was a W/F with dark hair. (See Ofc. Mitros supplemental report for additional details.)

I responded to the area traveling North on S. Wood Ave. As my vehicle

approached the area I observed the individuals matching the description given to me by Ofc. Mitros. The actor with the white muscle shirt and shorts, later identified as Benjamin Buell, was standing on the ground facing the front of 107 S. Wood Ave and appeared to be holding something in his right hand. The actor with the dark hat and shirt, later identified as John Kaczor, was standing on the top of the steps looking down towards Mr. Buell. The female was sitting on the steps of the building. Upon discovering my presence Mr. Buell quickly tossed the item that was in his right hand towards the south side of the building and walked to the steps of the building.

I parked my patrol vehicle just south of 107 S. Wood ave and approached the three individuals. On the front of the building in the area that I observed Mr. Buell standing, the word "LITION" was written in green spray paint underneath the "DEMO" marking. On the front entrance to the building where Mr. Kaczor was standing were the letters "JE" in green spray paint. I also observed two open "Corona" beer bottles, one next to Mr. Buell and one next to Mr. Kaczor. I asked what was going on and Mr. Kaczor responded "Hello Chris Guenther!". I asked Mr. Kaczor if I knew him and he stated his name and reminded me that we played baseball together as children. Mr. Kaczor went on to state that they were just remembering the area before it is demolished. I asked where he lived and Mr. Kaczor stated he now lived on Essex Ave. I asked Mr. Kaczor if he was all right, as his complexion was pale and his eyes were irritated. Mr. Kaczor became irate and began yelling toward me, stating "You pigs are all the same!". At this point I instructed Mr. Kaczor to go home. Mr. Kaczor continued to yell and curse, stating "Who are you to tell me what to do like that!". Again I instructed Mr. Kaczor to leave the area and go home. Despite the urging of his associates Mr. Kaczor still refused to leave. At this point Mr. Kaczor was placed under arrest.

I radioed central dispatch to send an additional unit to my location, as Mr. Kaczor continued to yell and curse. I attempted to place Mr. Kaczor's hands behind his back to handcuff him, but Mr. Kaczor pulled away. I pushed Mr. Kaczor against a fence and again attempted to secure him. Mr. Kaczor continued to resist my control, as he grabbed ahold of the chain link fence and could not be pulled off. I ordered Mr. Kaczor to let go of the fence, which he refused stating "I can't believe you are going to arrest me you asshole! Come find me in plain clothes!". At this point, due to the level of resistance by Mr. Kaczor and his increasingly violent behavior I utilized my O.C. spray to attempt to bring Mr. Kaczor under control and allow him to be secured. Additional units arrived and assisted as I secured Mr. Kaczor and placed him into the rear of unit # 709. Mr. Kaczor continued to yell and curse.

Recovered from the front of the building where Mr. Buell was standing was a can of blue spray paint. Recovered from the side of the steps where Mr. Kaczor was standing was a can of green spray paint. Two additional cans of spray paint were recovered along the south side of the building. The items

were tagged as evidence and placed in evidence locker # 12. Pictures of the graffiti were taken using the camera from unit # 717, photo numbers 172-7271 - 172-7273. Mr. Kaczor was transported to LPD HQ in unit # 709, followed by car #20. Mr. Buell was also placed under arrest and transported to LPD HQ in unit # 703. While being placed into the unit # 703 Mr. Buell spontaneously uttered, without any provocation or questioning, "I don't understand what the big deal is over spray painting, they are doing it all over town."

While at LPD HQ Mr. Kaczor continued to yell and curse at this officer. Mr. Kaczor stated again "just wait until I find you in plain clothes. Recovered from the right front pocket of Mr. Kaczor's pants was a bottle of VISINE eye drops as well as an additional unmarked squeeze bottle containing a clear liquid. The bottle was tagged for safekeeping and analysis and placed in locker # 13. A warrant check was conducted on Mr. Buell with negative results. A warrant check conducted on Mr. Kaczor revealed S-2006-001913, a contempt warrant out of Atlantic City Municipal Court in the amount of \$178.00, .

Mr. Buell was charged with 2C:17-3a1 (criminal mischief) and released on summons # S-2007-000173-2009. Mr. Buell was additionally issued municipal ordinance 2009-SC-006845 for 3-5.1a (drinking in public), both with a court date of 06-20-2007 @ 1800.

Mr. Kaczor was charged with 2C:17-3a1 (criminal mischief), 2C:29-2a(1) (resisting arrest), and 2C:33-2a(1) (disorderly conduct) and was held on Warrant # W-2007-000532-2009. More specifically, he states two companies have been harassing him via the internet and social media by spreading false information and completing OPRA requests attempting to gain information about him. [REDACTED] believes Mannhuber and Roman are owners or administrators of these two companies or businesses, namely "Ethicswatch LLC" and "B-Bear media" and that Mannhuber and Roman have been using these businesses to contact him, citizens in Linden, NJ and Dover, NJ in an effort to harass him. [REDACTED] believes that these businesses are based in Florida. He contacted their State's Attorney Generals office who advised him to make a police report in Linden, NJ. [REDACTED] states he has emails and other related documents and asked for a evidence.com citizen link so he could share the files.

[REDACTED] also stated that he was transported to the hospital in January 2019 and Roman and Hickey were referencing this situation during a Linden City council meeting in the months thereafter. [REDACTED] also learned that an OPRA request was submitted by "ethicswatch llc" in which they asked for all Linden Police CAD incidents for that one specific day. A request [REDACTED] believed was centered around obtaining information about his hospital transport.

Finally, [REDACTED] added that he has spoken to Robert Scutro in regards to "ethicswatch.com." Scutro informed [REDACTED] that Roman asked him to create an email account for ethicswatch.com some time ago. [REDACTED] was sent an evidence.com citizen upload link. [REDACTED] stated he is already aware of complaint procedures.

While on patrol in marked unit 708, I was dispatched to 318 Jefferson Avenue on a report of a Domestic in progress and a white vehicle fleeing the scene.

Upon arrival, I made contact with the caller, Vanesa Scozzarro. Vanesa stated that her next door neighbor-victim, later identified as [REDACTED] that resides at 317 Jefferson Avenue was assaulted by another male. Vanesa stated that she was not involved, instead she dialed 911 for assistance. Vanesa then added that the white vehicle fled the scene before Police arrival. At this time, I observed a Ring camera at Vanesa's residence.

At this time I made contact with [REDACTED] stated that he was not physically assaulted, however the front window door was broken. [REDACTED] started to explain that he placed his washer/drier on the Facebook marketplace for free pick up. He was then contacted by "Tony" (no further information) about the washer/drier. During the course of conversation, Tony brought up to [REDACTED] attention that John Kaczor contacted him about the washer/drier. [REDACTED] then invited Tony in the basement to take a look at the merchandise. At this time, Tony started to ask [REDACTED] if the washer/drier are in working condition and started to get agitated about their condition. [REDACTED] and Tony both left the basement when Tony became very aggressive towards [REDACTED] and got in his face. Tony's friend (no further information) was trying to hold Tony back. At this time, [REDACTED] decided to go back in the house and closed the storm door. Tony then confronted him again and broke the window in the storm door with his knee causing the window to shatter. After shattering the window, Tony and his friend both fled in a white four door vehicle bearing New Jersey registration: T71FS8 (possibly Chrysler) towards West Stimpson Avenue and made a left towards South Wood Avenue. I was provided with the plate number by [REDACTED]. It should be noted that the plate does not come back to anything.

[REDACTED] described Tony as: Hispanic male, approximately 5'7" in height, slim, light skin tone, gray sweatpants and red sweater. 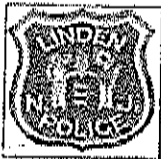
