She believes Mr. Rogers Ramierz is harassing her due to a post she made on FaceBook. Mrs. Tallon informed me she posted that Mrs. Ramierz is hosting MMA events at the New Egypt Primary School without the proper insurance. Since then she feels as if Mr. Ramierz has been harassing her. She advised me that on 1/31/24 while she was sitting at Tooties Diner she observed Mr. Ramierz stop on the side of the road, take his phone out, and take photos. She continued by saying she was unaware if he was taking photos of her or not. The second incident occurred on 2/1/24 when she left Tootie's Diner. She informed me that a server Oliva Miller called her, and said she watched Mr. Ramierz leave the parking lot of Twisted Stakes and follow her as she left. The third incident occurred today 2/5/24. Mrs. Tallon witnessed Mr. Ramierz drive past Tooties Diner three (3) times and turn his head to see who was in there. Mrs. Tallon is unaware if Mr. Rogers was looking for her or not. I then advised Mrs. Tallon of the complaint procedure. No further actions were taken.

Mr. Kertis stated that he feels that this movie is about him specifically because at the end it says "Plumsted City was quiet until Dirty Dan and the Kurtis family arrived". Mr. Kertis also stated he is in fear for his family and believes this is an act or harassment.

On the above date and time, three individuals later identified as, Albert Canka, Danilee Watkins, and William McGovern Jr came into police headquarters to file a report of Criminal Mischief/ stolen property at 149 Bridgetown Rd. William advised me that he works security on the property and was working there overnight on 1/25/24. William continued by telling me between the hours of 9 pm and 11:30 Pm he heard a truck come up and down the driveway at three different times. He then advised me he contacted his boss Mr. Danilee Watkins who informed him not to do anything. I asked William if he saw the trucks, to which he responded "No I just heard them". Mr. Watkins then stated that at 8:30 Am on 1/26/2024 he attempted to leave the property but was unable to, due to a new lock being placed on the gate. Mr Watkins advised me this new lock was not placed on the gate by any of his managers. He continued to tell me he believed Rogers Ramirez was responsible for taking the original lock and replacing it with this new one. I then asked Mr Watkins why he felt Mr Ramirez was responsible for stealing and replacing the lock, of which he responded in retaliation for his friend being evicted from the property. It was explained to me that Jennifer Hlubik had been evicted from the property and she is friends with Mr Ramirez. Mr. Watkins also advised me that Mr. Ramirez had already been trespassed from the property on 1/22/23 and has returned numerous times since. I asked Mr. Watkins why he didn't report it and he informed me he did not witness it but had seen it on Mr. Ramirez's FaceBook. It should be noted that Mr. Watkins could not provide this officer with any evidence of Mr. Ramirez trespassing at this time.. Mr. Watkins had also stated that Mr. Ramirez had filed a false police report against him and would like to file a criminal charge against Mr. Ramirez. Mr. Watkins was advised of complaint procedures and that this incident would be documented. No further actions taken at this time.

Upon my arrival I met with Rogers Ramirez who was looking to get an escort to 149 Brindletown Rd (GreenCell Farm). Mr. Ramirez stated that Danilee Watkins threatened to kill his animals if they were not removed off the property. I advised Mr. Ramirez to email me any messages or emails that he received regarding this incident so they can be attached to this report. Mr. Ramirez wanted this incident documented in case any further actions take place.

I was able to get in contact with Danilee over the phone who advised me that he never said he was going to kill any of Mr. Ramirez's animals. Danilee did explained to me that the owner of the property Albert Canka gave an eviction notice to both Jennifer Hlubik and Rogers Ramirez that they have 30 days to remove all of their belongings off the property.

I spoke with the owner of the property Albert Canka over the phone who advised me that due to multiple violations of the lease agreement, Mr. Canka sent both Mr. Ramirez and Ms. Hlubik an eviction notice through text message. Mr. Canka stated that there was never an official court document regarding this incident besides the text messages between both parties that they mutually agreed on. Mr. Canka was able to provide me with screenshots of the messages regarding the eviction notice which will be attached to this report. Both Mr. Ramirez and Ms. Hlubik are working on getting all the animals off the property. They stated that they will have all the animals off the property by the end of the day on 01/25/24, Mr. Canka stated that he was okay with that. No further police actions taken at this time.

On 01/03/24 at approximately 10:20 hours, I, Ofc. Talty #280, met with Jennifer Hlubik and Rogers Ramirez at police headquarters in reference to a walk-in report.

While speaking with Rogers and Jennifer, they explained there is a tenant on the farm (149 Brindletown Road) Danilee (Dan) Watkins, who has been harassing them since early December 2023.

Some time in December, Dan was accused of an incident involving a cannabis farm he allegedly operates off of the property, and believes Rogers and Jennifer were the ones to report it to authorities (EPA, etc.). Rogers stated they were not the ones who reported it, but stated Dan has been harassing them ever since.

Rogers also reported another incident from 12/10/23 where Dan allegedly brandished a handgun in front of Jennifer and Rogers. Rogers stated Dan asked them to go to a shooting party on the farm at which time Rogers declined. When Rogers declined, Dan allegedly unholstered his weapon, believed to be a Springfield 9mm handgun, and waved it in a "tactical" manner. Rogers stated he did not make a threat nor did he point the weapon at either of them but it was still brandished and believes it was done to intimidate them.

Rogers stated Dan has sent him and Jennifer numerous text messages regarding the farm since 12/14/23 and just recently stopped 01/01/24. Rogers has not responded to Dan since 12/14/23. I advised Rogers I will document this for future reference and that is is currently a civil matter and must go through our court administrator Courtney Meyer to which he stated he is already in touch with her.

I also provided Rogers and Jennifer with previous documented case numbers and my email in the event they want to send screenshots of text messages to add to this case.

At the end of the conversation, Rogers and Jennifer requested a police escort to the farm to prevent any conflict between the two and Dan. Ofc. DuBlois #293 then escorted them for a keep the peace related incident without further report.

There is no further report at this time.

On the above date and time I Sgt. Garrigan 273 responded to 149 Brindletown Rd for an officer requested/ property damage. Upon arrival I spoke with Danilee Watkins who stated he is one of the managers at the farm located at 149 Brindletown Rd. Mr. Watkins said he has an ongoing issue with Rogers Ramirez and has confronted him about this issues. Mr. Watkins believes that Mr. Ramirez damaged the front gate of the entrance to 149 Brindletown Rd this morning by taking it off its hinges and moving it to the side of the driveway. Mr. Watkins said in the past he has received complaints that Mr. Ramirez or someone Mr. Ramirez knows sleeping in an RV that is parked close to the land that they lease from the farm. Mr. Watkins has also had issues with Mr. Ramirez having unauthorized vehicles on the property that are driving onto other land that is sub leased through the owner of the property. Mr. Watkins has reached out to the owner of 149 Brindletown Rd to express his concerns over other violations that Mr. Ramirez and his partner Jennifer Hlubik have committed, such as failure to have Mr. Ramirez covered by the farms insurance policy. At this time I reached out to the owner of the property, Albert Canka ((917)731-4432 @10:48) who stated he is aware of the ongoing issues and has other concerns that he did not mention. Mr. Canka said he has sent Mrs. Hlubik and Mr. Ramirez a list of items that need to be updated and brought up to proper standards in order to maintain the leased land. Mr. Canka has given the two parties 30 days to get the list done otherwise they will be evicted from the property. After speaking with Mr. Canka I contacted Mr. Ramirez ((609)903-5960 @ 11:28) to inform him that he does not have access to anyone else's land on that property. Mr. Ramirez denied all allegations against him and stated he goes to the property to run his program for wounded vets and to take care of the animals as he has since 2019 when he and Mrs. Hlubik first leased the land together. Mr. Ramirez did state that they received a letter from Mr. Canka about the new standards that they need to meet and comply with and are currently working on resolving the issues. I have informed Mr. Ramirez that he is not to go onto anyone else's land on that property as per Mr. Canka. It should be noted that Mr. Watkins and Mr. Canka do not have any physical proof of Mr. Ramirez doing anything wrong and it is mostly word of mouth from other tenants around the property. No further police action taken at this time.
