These emails advise the recipient that 'attached is a copy of the commission statement' and is signed with her name, business, and telephone number as well as an attached file. She believes that the file is some sort of virus so she did not open it. Due to the nature of ~~XXXXXX~~ business, she deals with clients personal and sensitive information and wished the incident be documented.

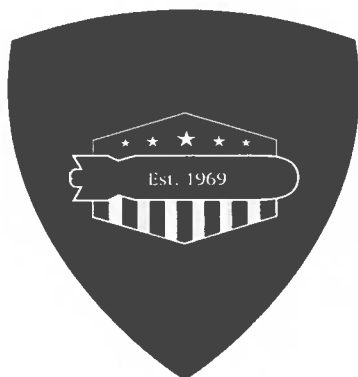

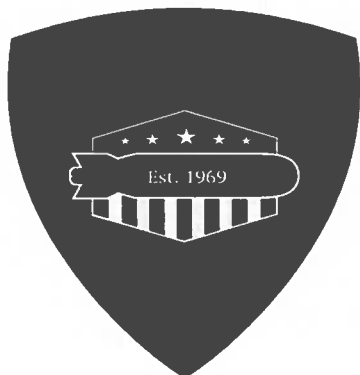

SUPPLEMENTAL INVESTIGATION REPORT

On Thursday October 24, 2024 I PTL. Calvetto #315 was assigned to routine patrol within the jurisdiction of the Borough of South Toms River operating marked patrol unit 2907. At approximately 0904 hours I was dispatched to the South Toms River Police Department to speak with an individual regarding a harassment report. Upon arrival I made contact with the complaining party [REDACTED] who is known to this officer through previous police encounters. [REDACTED] stated she was having issues with her neighbor that lives across the street from her. The neighbor was identified as [REDACTED] who is also known to this officer through previous police encounters.

██████ advised officers that for some time now ██████ has harassed her continuously to the point she has put her residence up for sale. Most recently ██████ advised me that ██████ has been harassing her through a community forum for the HOA of the Wiley Way town homes. The HOA was advised to park their cars on the street outside the area for sealcoating. ██████ stated she got home late one night and was leaving early so she parked her car in front of her residence. ██████ took a picture of her vehicle and made comments on the forum including that ██████ is selfish and entitled. ██████ also stated that ██████ has approached her friend when she came over and asked who she was. ██████ stated her friend was verbally assaulted and will no longer return to the residence due to the confrontation with ██████. ██████ also mentioned various other instances where ██████ belittles her and calls her names.

██████ wanted it documented stating she does not feel safe with ██████ and is not sure what will do calling him unpredictable. Attached is screen shots ██████ sent me of the HOA forum. Nothing further at this time.
