Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On Tuesday, July 16, 2024, at approximately 14:17 hours, they were dispatched to respond to the Hank Gallo Community Center (Administration Building) in Lincoln Park, on a report of an assault. Upon arrival they met with the victim who was identified as Mr. Walter E. Kierney, a 41 Caucasian male, DOB: , Residence: , Jersey City, New Jersey 07306. He stated that he was riding his electric bicycle to work on Belvidere Avenue in Jersey City. He states that as he approached the Gautier Avenue entrance to the park, he observed 2 vehicles blocking the walkway. He asked if they could move their car and one of the actors responded, "just go." He proceeded to ride his bicycle into the park when he was pushed from behind causing him to fall on the ground. He states that 4 Hispanic males struck him numerous times in the face and body while the group attempted to steal his electric bicycle. He states that both vehicles had New Jersey State registrations but was unable to see the make, model and license plate numbers because his glasses had been knocked off during the robbery.
