February 1, 2022 at 19:24 hours:

I was dispatched to Target, located at 5000 Hadley Center Drive, for the report of a known shoplifter, currently in the store. Upon my arrival at the store, I spoke with Target's Loss Prevention Officer, Nelson Ortega. I was advised by Ortega that they were currently watching a female, later identified as Soje Rivera, who is known to shoplift from their store. Ortega stated the female currently has several open cases with them for shoplifting.

At this time, I observed Rivera on video surveillance walking up and down different aisles in the beauty & medication section. Rivera was taking items off the shelf and placing them in her shopping cart. Rivera then covered the items with a jacket or pieces of clothing. This went on for about 10 minutes before Rivera was observed walking towards the exit door near the Pharmacy. It was obvious at this point that Rivera was attempting to leave the store without giving proper payment for the items she was concealing in her shopping cart.

With the assistance of Ortega, Rivera was confronted and stopped outside of Target near the parking lot. Due to me observing the following criminal violation in person, Rivera was placed under arrest for shoplifting. Rivera was placed in the rear of marked patrol unit # 59, then transported to headquarters by Officer DeBiase, to begin the booking process. The stolen items which are beauty product, over the counter medications, and clothing which were later found to total \$826.57.

All items were returned to Ortega on scene. A property form was completed to document the items taken which were subsequently returned to the store. While still on scene gathering information on the total price of the items stolen. Ortega indicated that there was a second female currently being observed, who was concealing items in a bag. I remained on scene until this second female, who doesn't appear to be involved with Rivera was subsequently arrested, see report # 22-04682 for further information.

At headquarters, I was advised by Sgt. Bullock that drug paraphernalia was located on her Rivera. Dispatcher/Matron Samoya, who is a female, discovered that Rivera was concealing the following items underneath her bra:

- 1) One white waxy fold, labeled in red "Chicken Waffles", with suspected heroin residue.
- 2) One broke glass pipe with "Chore Boy at the tip, commonly used to inhale crack cocaine.
- 2) One use hypodermic needle.

A photograph of the items located on Rivera were taken and attached to this report. The hypodermic needle and glass crack pipe were properly disposed of. The white waxy fold containing suspected heroin was marked as evidence JO-2, entered into the BEAST management system, and placed in evidence locker #16.

Prior to leaving Rivera signed and was given a copy of the Central Judicial Processing Notice, acknowledging her court date of February 25, 2022 in New Brunswick. Officer Debiase provided Rivera with a Blue Cares Card, after asking for assistance with her drug habit. Video surveillance of this incident was obtain by Ortega, labeled as JO-1 and placed into evidence locker #16. Rivera never indicated having any dependents that solely rely on her for her care or sustenance.

On 11/14/2022 at 17:12 hours, I was dispatched to Shoprite, located at 3600 Park Avenue, for the report of a shoplifting that occurred on 11/11/2022.

Upon arrival I spoke to James Marmo who is the loss prevention officer for ShopRite. Marmo stated a female, who he identified from previous shoplifting as Soje Rivera, entered the store on 11/11/2022 at 09:30 hours. Marmo stated that he was alerted to Rivera entering the store from the facial recognition systems and was also alerted that items were stolen from the store when the count of inventory was off.

Marmo showed me video footage of the shoplifting which showed Rivera exiting the passenger side of a silver Jeep Compass, bearing New Jersey registration # [redacted] affixed to the front of the vehicle. The driver of the vehicle stayed inside of it during the entire duration of the incident. Rivera then enters the store and proceeds to fill a shopping cart with numerous items. Rivera's main focus was over the counter medicines near the pharmacy. Rivera can be observed taking many different types of allergy medicines and various other items valuing \$2,001.00. Rivera was wearing a black jacket, black ripped jeans, a white skull cap, and black boots.

After filling up her shopping cart she passes all points of sale without paying and exits the store at approximately 09:45 hours. A receipt as well as footage on a DVD were logged into evidence and placed into locker #16. The New Jersey registration # [redacted] comes back to Tracy Hawkins from [redacted] Marmo who is familiar with the complaint process stated he would sign a complaint later in the week with the courts.

I compared photos of Rivera from previous arrest records within our department and it is Rivera who shoplifted. A check of the vehicle used did not show Rivera ever getting summons in the vehicle. With the ability to identify Rivera complaint #S202200411 was signed against Rivera. I attempted to make contact with Rivera with the number listed from previous incidents but the number was no longer in service. After reading a TRAK message from Clark PD I attempted to reach her at Town Inn and Suites with negative results. I responded to [redacted] due it being her last listed address on her CCH from 07/28/2022 with negative results.

I responded to Target (5000 Hadley Center Drive) on report of a shoplifting in progress. Loss prevention officer Erin Demko was relaying to dispatch that a female was stealing items in the CVS Pharmacy section of the store. The female was described as wearing all black with red hair. She was further described as concealing merchandise in one of Target's own suitcases. Off. McCoid and Off. Parham arrived just prior to myself. Dispatch advised the female was now nearing the opposite exit of where the above units were located and pulled towards it. As I arrived I observed a female matching the suspect's description pushing a shopping cart full of merchandise, with a suitcase in it. See page 2.

She had just exited the store and upon observing my vehicle, marked police unit 97, the suspect paused and tried to back up and re-enter the store. I exited my vehicle and confronted the suspect, later identified as Soje Riveramarine.

Soje would initially provide a false name to Off. McCoid of Angelica Rivera for which a NJ driver license was located and an arrest/booking/complaint process was completed. Livescan results positively identified Soje correctly and she later confirmed that she had given a false name.

LP Erin Demko, was on scene to identify Soje as the shoplifter. Off. Parham and Off. McCoid remained with her while I returned to the LP office to review surveillance footage. Erin directed me to the monitors where Soje could be seen taking items from the aisle of the OTC medication section and placing them inside the suitcase (which was not previously paid for and an included stolen item). Erin also directed me to footage where Soje was taking assorted beauty products and adding them to the suitcase as well. The items totaled \$1,026.46.

With the stolen items Soje then crossed the threshold of the store's exit where I would later confront her. She was placed under arrest and transported to headquarters by Off. Parham. A female officer, Off. Perry, was requested for a search incident to arrest of Soje in the booking room which revealed drug paraphernalia on her person. Off. Perry located a glass pipe with suspected crack cocaine residue and metal wool (common methods/accessories for smoking narcotics) and an empty glassine fold with no markings (common packaging for heroin).

Erin provided a copy of the surveillance footage which was labeled MS-1. The empty fold of heroin was labeled MS-2. The glass pipe and metal wool was labeled MS-3. Off. McCoid's handwritten notes of Soje's false name was labeled MS-4. All were entered into the BEAST and placed into locker 16 except for the glass pipe and metal wool. It was photographed (see attached) and placed into a sharps container.

Other than processing Soje initially under a false name, she was fingerprinted and booked without incident.

During the booking process dispatch advised Soje had multiple detainers and was wanted out of multiple jurisdictions:
