ON THE ABOVE DATE AND TIME, UNITS RESPONDED TO 34 RONA STREET FOR A COMPLAINT THAT A NEIGHBOR WAS REMOVING THEIR FENCE. THIS AGENCY HAS RESPONDED TO THIS LOCATION ON APPROXIMATELY THREE (3) SEPARATE OCCASIONS FOR SIMILAR INCIDENTS.

I ARRIVED ON SCENE AND SPOKE TO THE HOMEOWNER (GERTRUDE WASILISHEN) OF 34 RONA STREET. SHE AND HER HUSBAND ADVISED ME THAT THEY OBSERVED (ON VIDEO SURVEILLANCE) THE HOMEOWNER OF 30 RONA STREET ATTEMPTING TO DIG UP THE WESTERN MOST FENCE POST BETWEEN THE TWO PROPERTIES.

IN PAST INCIDENTS AT THIS LOCATION, THIS AGENCY WAS ADVISED THAT THE BOROUGH OF INTERLAKEN ZONING OFFICER WAS UNABLE TO DETERMINE THE PROPERTY LINE ON SURVEYS AND THAT THEY WOULD NEED TO ADDRESS THE ISSUE IN CIVIL COURT.

DUE TO THE ZONING OFFICER NOT BEING ABLE TO DETERMINE THE PROPERTY LINE, THIS AGENCY IS UNABLE TO DETERMINE THE LEGAL OWNER OF THE FENCE POST. I ADVISED WASILISHEN THAT I WOULD MAKE THE COMPLAINT A MATTER OF RECORD AND THAT THEY WOULD NEED TO FOLLOW UP IN A CIVIL MANNER.

AFTER SPEAKING TO THE HOMEOWNERS OF 34 RONA STREET AND WENT TO 30 RONA STREET AND SPOKE TO HOMEOWNER (PATRICIA ENGLERT). I ADVISED HER THAT THERE WAS SURVEILLANCE FOOTAGE OF A SUBJECT ATTEMPTING TO REMOVE THE FENCE POST. I ADDITIONALLY SUGGESTED TO HER THAT SHE NOT ATTEMPT TO REMOVED THE POST AND STAY OFF THE "IN QUESTION" PROPERTY UNTIL DETERMINATION CAN BE MADE IN CIVIL COURT AS TO WHO THE RIGHTFUL OWNER IS.

NO POLICE ACTION TO BE TAKEN AT THIS TIME.
