Ptl. Losquadro and I responded to the listed location for a neighbor dispute regarding a fence. It should be noted patrols have responded to this residence multiple times regarding the same matter. Upon arrival, we spoke with the resident of 34 Rona St, Thomas Wasilishen. He stated that today, the resident of Patricia Englert, had a contractor come over and had attempted to remove the fence post, but was stopped from doing so. Wasilishen stated he has already filed a complaint with Deal M.C. and has obtained an attorney. Englert was also spoken to and advised again, that she is not to have any contractor remove or replace any kind of fencing, fence posts, etc. until a court decides the matter. She further stated that she has already begun the motions to obtain an attorney as well.

It should be noted that the contractor Englert hired did move the fence and fence posts that have already been removed back onto Wasilishen's property.

After clearing, I responded to Interlaken Borough Hall and spoke with Lori and Gina. They both stated the zoning officer made contact with both residents and advised them he cannot read their survey and make a determination of property lines. They need to contact attorneys and have the matter resolved in civil court.
