Dispatched to the location regarding a neighbor dispute. Upon my arrival I spoke with the homeowner of 34 Rona St. Mr. Wasilishen. He stated that his neighbor Ms. Englert maliciously dumped garbage onto his property. Mr. Wasilishen showed me the garbage in question. It was 4 cardboard boxes on the alleged property line. It should be noted that only approximately 1-2 feet section was crossed over the alleged property line.
