Body Worn Camera Used NARRATIVE On October 14th, 2022, Rebecca Halbach contacted the Absecon Police Department requesting a welfare check on an animal that was adopted from her. In September, a resident of Absecon, Monique Lodato, adopted an animal from Halbach. Lodato later insisted that she no longer wanted the animal as it was several weeks older than she had previously believed. Halbach advised Lodato that she could simply swap the dog out for a different puppy, and this transaction had taken place on October 2nd, 2022. Halbach advised Patrol that there were no adoption papers signed for the second animal. Halbach stated that it was raining on the evening of the 2nd, so the two parties exchanged

animals, and Lodato was provided with new adoption papers to be filled out and sent back at a later date, instead of standing out in the rain. Following this transaction, the two parties had been in communication and Lodato advised that while she did not want to give the puppy back, she did not feel comfortable signing the adoption papers because she believes the puppy was not in good health.

Halbach was requesting Patrol oversee the signing of the adoption papers or instruct Lodato to return the animal. Halbach was advised that the adoption of an animal is not a police matter and that those issues need to be addressed in civil court. Halbach then advised that she does not believe Lodato is capable of caring for the animal and requested that Patrol check on the dog.

Patrol went to Lodato's residence, 11 Lisbon Avenue, and made contact with her, in front of her home. Lodato brought the puppy outside, what she believes is a Shar Pei mix, now named "Deuce". Deuce appeared to be in good health and well taken care of. Lodato advised that she had made an appointment with Absecon Vet to treat what she believes is Kennel Cough and will be following up with them to make sure the puppy stays healthy.
