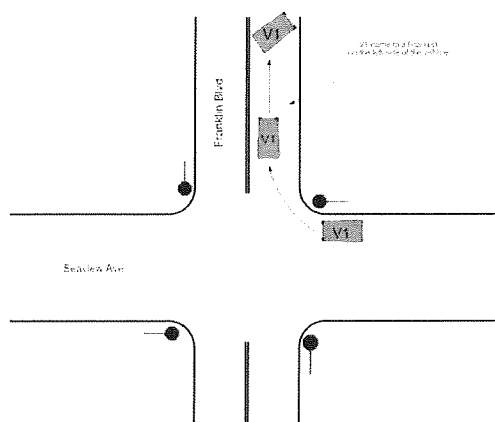

145. Crash Description/Narrative

Driver 1 verbally stated she was turning onto Franklin Blvd from Seaview Ave when her vehicle started to teeter. Driver 1 verbally stated she was trying to regain control of the vehicle by applying the brakes. While attempting to apply the brakes (Box 118a) Driver 1's flip flop became lodged in the gas pedal. It was at this time, (Box 105) the low-speed vehicle tipped over onto its left side. Driver 1 had eight (8) female juveniles in the Low-Speed Vehicle. None of the occupants of the vehicle were wearing their seatbelts and due to the overcapacity multiple juveniles were sitting on the laps of other occupants. (Box 84) Passenger F, Catherine Medland, was standing up in between the passengers on the back of the low-speed vehicle and holding onto the handrailing located on the rear of the vehicle. When patrol arrived, the vehicle had already been lifted back up. EMS arrived on scene and transported two of the occupants to Atlantic City Medical Center for further medical attention.

Additional summonses were issued for (0180 E24 026909) Failure to Wear a Seatbelt and (0180 E24 026907) Driving an Unregistered Vehicle. The summonses issued in relation to this crash state there is no plate due to the model of the vehicle not being in the system.
