IT SHOULD BE NOTED

DEMSKI APPEARED

I OFFERED TO TAKE DEMSKI BACK HIM MOM'S RESIDENCE WHILE WE WAITED AND DEMSKI AGREED TO RETURN BACK TO THE RESIDENCE. AT THIS TIME, DUE TO A TRANSPORT, I SEARCHED DEMSKI FOR WEAPONS OR CONTRABAND AND LOCATED ONE MACE PEPPER GEL CAN IN DEMSKI'S SHORTS. I TOOK POSSESSION OF THE CAN AND PLACED IT IN MY FRONT PASSENGER SEAT IN MY PATROL VEHICLE. I THEN CHECKED THE REAR BACK SEAT FOR WEAPONS OR CONTRABAND WITH NEGATIVE RESULTS. DEMSKI WAS PLACED IN THE REAR SEAT AND TRANSPORTED BACK TO HIS RESIDENCE SAFELY. THE REAR SEAT CAMERA WAS ACTIVATED DURING TRANSPORT.

UPON ARRIVAL AT THE RESIDENCE, DEMSKI WAS SEATED OUTSIDE AND P/O PAUCIUOLLO STAYED WITH HIM WHILE I WENT INSIDE THE RESIDENCE TO SPEAK WITH DEMSKI'S MOTHER. DEMSKI'S MOTHER STATED HER SON HAS BEEN ACTING

AND THE FACT THAT THE CAN WAS DOUBLE THE LEGAL LIMIT, I SEIZED THE MACE CAN FOR DESTRUCTION. WHEN I ASKED DEMSKI WHERE HE GOT THE CAN HE STATED THAT HE FOUND IT AT THE BUS STOP ON DENOW RD. DEMSKI WAS ALSO ADVISED HE CANNOT POSSESS A MACE DOUBLE THE LEGAL LIMIT.

ONE MACE PEPPER GEL CAN WAS PACKAGED AND ENTERED INTO THE BEAST EVIDENCE MANAGEMENT SYSTEM. THE CAN WAS STORED INTO TEMPORARY EVIDENCE LOCKER #76. THE KEY FROM EVIDENCE LOCKER #76 WAS SECURED IN THE ROLL SAFE, IN ACCORDANCE WITH DEPARTMENT POLICY. DETECTIVE LIOTTA #57 WAS ADVISED THAT THE EVIDENCE WAS ENTERED FOR DESTRUCTION.
