ON TUESDAY, 10/03/2023, AT APPROXIMATELY 2128 HOURS, P/O ALVARO #64 AND I (P/O LUDWIG #69) RESPONDED TO THE HOPEWELL TOWNSHIP POLICE DEPARTMENT (HTPD) LOBBY TO SPEAK WITH A WOMAN IN REGARDS TO HER SON MAKING HER FEEL UNSAFE.

UPON ARRIVAL, I ACTIVATED MY BODY WORN CAMERA (BWC) AND MET WITH ANN DEMSKI, WHO WAS ACCOMPANIED BY HER DAUGHTER, BERNADETTE GRU AND HER GRANDDAUGHTER (UNIDENTIFIED). THEY WERE ADVISED THAT THEY WERE GOING TO BE AUDIO AND VIDEO RECORDED DURING OUR INTERACTION.

ANN STATED THAT HER SON, [REDACTED]

SGT. MIRRA #47, SGT. PANZANO #55, P/O VACCARINO #45, P/O ALVARO, AND I WENT TO [REDACTED] WOOLSEY CT TO MAKE CONTACT WITH ED. UPON ARRIVAL, I ACTIVATED MY BWC WHICH ACTIVATED MY MOBILE VIDEO RECORDER (MVR). I OBSERVED ED SITTING OUTSIDE OF THE FRONT DOOR PLAYING WITH HIS GUITAR. ED INITIALLY THOUGHT THAT OFFICERS WERE AT HIS RESIDENCE TO [REDACTED]

WHILE SPEAKING WITH ED, I OBSERVED A BILLY CLUB ON THE TABLE DIRECTLY IN FRONT OF HIM. ADDITIONALLY, WHEN ED ALLOWED P/O ALVARO AND ME INSIDE OF HIS HOUSE, P/O ALVARO OBSERVED A BLACK HANDLED MACHETE IN THE CORNER OF HIS BEDROOM, LEANING UP AGAINST THE WALL. BOTH WEAPONS WERE SECURED FOR SAFEKEEPING AND PLACED IN UNIT #212. THERE WERE NO OTHER WEAPONS OBSERVED INSIDE OF THE RESIDENCE.

BOTH WEAPONS WERE ENTERED INTO THE BEAST EVIDENCE MANAGEMENT SYSTEM. THE WEAPONS WERE SECURED IN TEMPORARY EVIDENCE LOCKER #72. THE KEY TO TEMPORARY EVIDENCE LOCKER #72 WAS REMOVED, DROPPED INTO THE ROLL TOP SAFE AND THE HANDLE WAS SPUN. A VOICEMAIL WAS LEFT FOR DETECTIVE COLLINS #59 ADVISING HIM OF THE EVIDENCE STORED IN TEMPORARY EVIDENCE LOCKER #72.
