Brian explained that Hireflux's payroll company, MyPayrollHR was hacked

and employees were blaming Brian for the complications with their paychecks.

Brian wanted the harassment by Brittany to stop and asked that I call her and advise her to stop.

I provided Brian with a Citizen's Information Card and told him I would contact him after speaking with Brittany.

At 0012 hours on Saturday, September 7th, 2019 I made contact with Brittany and advised her to stop posting Brian's personal information. She advised that she understood and told me she would stop.

I then contacted Brian and explained to him my conversation with Brittany.

Scene was then cleared.

On the above date and time, I was dispatched to 19 Patricia Pl. for the report of an injured deer.

Upon arrival, I made contact with the resident of 19 Patricia Pl., Mr. Brian Fabiano. Brian stated that for the last two days, he has heard a deer crying coming from the woods behind his house. Brian led me to the deer which was located in a small thicket adjacent to his home. The deer was a juvenile and appeared to be injured and malnourished. The deer attempted to get up several times, but was unable to move due to an apparently broken neck.

I retrieved my department issued shotgun from Unit 14 and discharged a single slug into the injured deer, destroying the animal. Brian stated that he

would collect the deer now instead of waiting for animal control to come retrieve it.

Scene cleared, nothing further at this time.

Upon arrival, Officer Mordecai and I spoke to the resident, Brian Fabiano, who stated that his wife, Katie Fabiano, witnessed individuals in a gray Jeep Grand Cherokee stop in front of their house, take pictures of their house or car, and drive away. Brian showed Officer Mordecai and I a still photograph of the registration number on the Jeep Grand Cherokee (NJ: R67MXW). In addition, Brian showed Officer Mordecai and I home security camera footage of the Jeep Grand Cherokee's occupants taking photographs of the house. We advised Brian that we would look into the incident.

Later at headquarters, it was discovered that the Jeep Grand Cherokee is registered to a Donna M. Passias. I advised dispatch to call Howell Police and ask that they make contact with Donna to advise her to call Monroe Township Police in regards to the aforementioned incident. Donna then called the Monroe Township Police Department and Officer Mordecai answered the telephone. Donna handed the telephone over to her son, Nikolas Passias, so that he may explain the incident. Nikolas told Officer Mordecai that he and his friend, Domenic Cerniglia, were driving around Monroe Township and decided to stop in front of 19 Patricia Place to take pictures of the house because Domenic used to live in that house.

I called Brian Fabiano and advised him that we looked into the incident and there appeared to be no ill intent involved as the involved party, Domenic, used to live there. Brian was appreciative of the assistance.

On Wednesday, May 4, 2022, I took a walk-in report regarding a potential harassment.

At headquarters, I met with Brian Fabiano Jr., who informed me that Christine Skurbe, the president of the Monroe Township School District Board of Education, has been following him. After informing Brian that my body camera was activated, he requested that the body camera be turned-off. Per his request, the body camera was deactivated during our

interaction.

Brian, who is vocal about his concerns at board meetings, feels Christine's action are done in an attempt to silence, harass, and intimidate him.

Yesterday, Tuesday, May 3, 2022, Brian reported a similar concern involving Christine. Refer to incident #22015270 for further information.

Today, on the day of this report, Brian informed me that he had gone to the Monroe Township Municipal Building in the morning to pay his taxes. When parked, he alleges that Christine had parked behind him. So as to avoid any confrontation, Brian remained in his vehicle for around two (2) minutes. Seeing that Christine was still in her vehicle, Brian decided to leave the area and to subsequently report the incident.

Brian asked me to contact Christine and to advise her to refrain from following him. Though I explained the complaint procedure, Brian did not wish to file his own complaints at that time. He merely wanted to document the incident. I provided Brian with the case number and instructions on how he may obtain a report for his records.

I then spoke with Christine via department landline and informed her of my reason for calling. Christine advised me that she was not at the municipal building today, as Brian had claimed. She also informed me that she was, in-fact, at the municipal building the day prior, but was not there with the intentions as Brian had claimed. Hearing Brian's allegation(s), Christine informed me that she was now concerned. Now, Christine believes that Brian was following her and believes that Brian will attempt to harass her. Before explaining her options, I conferred with Sgt. Martinez in regards to the incident.

After discussing the facts of the incident, Sgt. Martinez contacted the Monroe Township Municipal Court. Sgt. Martinez conferred with court personnel to determine if complaints could be filed by either party involved with only one incident report being generated. We were advised that the involved parties would be permitted to do so.

Again, I contacted Christine and informed her that she may file her own complaints. I advised her that she would be able to obtain a probable cause form from police headquarters or that I could deliver the forms to her residence. Christine asked if I could bring the forms to her residence.

At Christine's residence, I spoke with her briefly and provided her with the probable cause form. Again, she informed me that she was not at the municipal building in the morning,, but was at the municipal complex the day prior. She stated that she was at police headquarters with Adi Nikitinsky, a fellow Board of Education board member, to discuss a report

that they had filed pertaining to Brian (Refer to incident #22015254 for further information). According to Christine, Brian has harassed board members in the past. Christine believes Brian may escalate in his actions. Christine informed me that an ethics complaint has been filed in regards to Brian's behavior. I was also informed that due to Brian's previous actions at board meetings, she has requested that an officer is present for the meeting on Thursday, May 5, 2022.

When I returned to headquarters, I contacted Brian via department landline and informed him of my findings. Afterwards, I advised him of the complaint procedures. Furthermore, I informed him that he could come to police headquarters to obtain a probable cause form. At that time, he did not indicate that he wished to file his own complaints.

No further police action was required at that time.
