Danilee requested this to be documented and stated he will be filing a Harassment Complaint through the Manchester Courts. I provided Danilee with the Case Number to this incident.

It should be noted, Danilee requested Officers to attempt to contact William and inform him Danilee, Olivia, and Joel request him to stop texting them. I attempted to contact William, yielding negative results.
