On the above date and time, P.O. Riepe #67, P.O. Pane #79, and I responded to the above location on the report of a dispute between a PSEG employee and a resident. Upon arrival officers on scene spoke to the PSEG employee, Joanne Stewart (DOB: 12/25/1980), who stated that she responded to 687 Blue Hill Road to discuss outstanding payments on an account. She stated that she informed the resident, Jonathan Calle (DOB: 08/07/1990), that his account was outstanding and if he did not make payment his services would be terminated. Mr. Calle reportedly stated to her that he could not make payment, and called PSEG. Ms. Stewart attempted to shut off Mr. Calle's services when he reportedly shoved her aside and threw her tool bag. He then asked her to leave the property. P.O. Riepe and I responded to Mr. Calle's residence to speak with him. Mr. Calle stated that he did not push Ms. Stewart, but did pick up her tool bag and ask her to leave his property. He claimed to have the incident on video, but when he attempted to show us it seemed the incident was not caught on the recording. Mr. Calle was informed that PSEG reserves the right to shut off services for outstanding payment, and that he should not physically interfere with their employees in the future. Ms. Stewart stated that she did not wish to sign complaints at this time. PSEG employees returned to Mr. Calle's residence with Lt, Guglielmotti #61 and P.O. Riepe #67 to shut off service to the home without incident. Both Ms. Stewart and Mr. Calle completed statement forms regarding the incident. The events that occurred have been captured by the Body Worn Cameras of Lieutenant Guglielmotti, Police Officer Riepe, Police Officer Pane, and Police Officer Ahmed; as well as the Motor Vehicle Recordings of Car 510, Car 52, Car 56, and Car 51.

At approx 8:30am. PSEG employee came banging at my door very aggressively. Employee was requesting 25% payment up front or she would shut off power + electricity.

When employee from PSEG came, she walked to the meter and became aggressive talking and cursing at me. PSEG employee became agitated and I told her to please leave my property now, as I was afraid of her attitude and demeanor.

I grabbed PSEG employee's bookbag and told her to please leave my home. As I grabbed her bag, she complained I pushed her and threw her bag away. Within seconds, she got in her car and drove away.
