I WILL NOT use the requested government records for a commercial purpose.

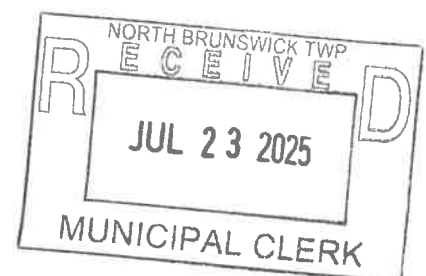
I AM NOT seeking records in connection with a legal proceeding.
