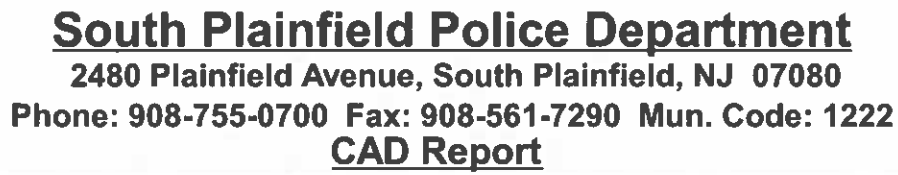

Parada, Kenneth: Ptl. 12/21/22 sperh 22-66566

On 12/21/2022, at approximately 18:30 hours, I responded to Target Department Store, 5000 Hadley Cent Drive for a shoplifting in progress with multiple people.

Upon my arrival, back up officer Ptl. Michael Alvarez was out in the parking lot with the following individual:

Defendants - Leslie Changotiban, Justin Cholota-Maldonado,
Involved Parties - Lizbeth Morales Chongo,

These individuals were unloading two shopping carts of items, which were shoplifted, into a white 2010 Nissan Murano (NJ Reg #S43MUE). The vehicle was owned by Changotiban. Also with Ptl. Alvarez was Nelson Ortega, Loss Prevention for Target, who observed the entire incident. We escorted everyone back into Loss Prevention Office to further investigate the incident.

Ptl. Alvarez was able to translate with everyone on scene while at Target.

Once inside, Ortega informed us there were two more females inside with two loaded shopping carts full of various items. Ptl. Neil Budhan was able to locate the two individuals/defendants, Evelyn Maldonado-Perez and Michelle Paguay-Chiliquinga.

Ortega advised all individuals entered Target together. Using surveillance video, Ortega monitored all individuals as they walked around the store. Ortega said they would meet up together and move items from one shopping cart to another shopping cart. Ortega observed [redacted] open an item, remove the anti theft device, and placed the item in another cart of another individual in the group. Ortega then observed the following exit the store past all points of sales:

Changotiban with her daughter, [redacted] with a shopping cart with approximately \$165.53 worth of items

Cholota-Maldonado and [redacted] with a shopping cart with approximately \$671.62 worth of items

Maldonado-Perez and Paguay-Chiliquinga were found with approximately \$967.72 worth of items in their shopping carts combined.

After reviewing the incident with Ortega, it was determined Morales Chongo was the only individual not involved with committing a crime. Morales Chongo was allowed to leave with her daughter. Changotiban allowed her daughter, [redacted], to leave in the custody of Morales Chongo.

All five defendants were transported to police headquarters to be processed. At headquarters all individuals were placed in the proper holding area. All were photographed, fingerprinted and processed.

At headquarters, Ptl. Alvarez and Ptl. Christopher Robles acted as translators to all defendants during the booking process.

Changotiban was charged with shoplifting (2C:20-11B(1)) and endangering the welfare of a child (2C:24-4, (2)). She was charged on a warrant (1222-W-2022-000450) and transported to Middlesex County Adult Correction Center.

Cholota-Maldonado was charged with shoplifting (2C:20-11B(1)), and he was released on a summons (1222-S-2022-000449) with a return court date to Middlesex County Courthouse in New Brunswick on 01/19/2023 at 0900 hours.

Maldonado-Perez was charged with shoplifting (2C:20-11B(1)), and she was released on a summons (1222-S-2022-000451) with a return court date to Middlesex County Courthouse in New Brunswick on 01/19/2023 at 0900 hours.

Paguay-Chiliquinga was charged with shoplifting (2C:20-11B(1)), and she was released on a summons (1222-S-2022-000452) with a return court date to Middlesex County Courthouse in New Brunswick on 01/19/2023 at 0900 hours.

Victim Notification Forms were filled out for all adult defendants. They were faxed over to Middlesex County by dispatch.

Target supplied video surveillance of the entire incident inside the store. The DVD was tagged as evidence labeled KP-1, and placed in evidence locker #16. The BEAST was utilized for the evidence.

On 12/21/2022 at approximately 18:19 hours, Ptl. Parada, Ptl. Alvarez and I, all responded to the Target located at 5000 Hadley Road on a report of a group of individuals shoplifting.

I arrived after Ptl. Alvarez and Ptl. Parada, however my body worn camera was already activated due to the use of my emergency lights. Once we gathered all of the suspects we brought them into the Loss Prevention Office and began the process of identifying them to determine who the who accompanied them belonged to.

During that process, the Loss Prevention employee who called about the incident, Nelson Ortega, advised me that a gift bag containing two (2) items did not belong to Target when they were taking inventory. I looked inside of the bag and noticed a pair of camoflauged GAP Kids pants still had a merchandise tag affixed to it. The other item was a pink children's fleece jacket that did not appear to be new, as the color was faded and the material felt old. There was not a receipt reflecting either item within the gift bag.

We asked all of the individuals we had detained if the items belonged to any of them or the children, and no one answered. As a result, I brought the bag into headquarters and entered the pair of pants whose tag read a value of \$34.95 into the BEAST Evidence Logging System as NB-1. I placed the pants into Temporary Evidence Locker #1 as Safekeeping, in the event that this item was shoplifted from another location or store.

On 12/9/2021 at approximately 17:21 hours I was dispatched to the area of 5000 Hadley Center Drive for the theft of merchandise. While in route dispatch advised me that the suspect was walking across the parking lot towards Five Guys restaurant 5020 Hadley Center Drive. Dispatch also advised the suspect was wearing a black jacket, light sweatpants, and a baseball cap.

Upon arrival of Five Guys I observed 2 black males waiting for an order placed. I approached both males and asked if they have been in Target recently. Jaquan Green stated they were in Target but did not steal anything. Green stated he just dropped his girlfriend off at the hair salon across the road.

Officer Marks responded to Target to get a better identification of the suspect. The other male Mustafa Williamson provided me with his name and picked up his food he was waiting for. When Williamson was asked about entering Target he did not provide me with an answer and Green insisted that they did not partake in a shoplifting. Officer Marks provided me with the description of the suspect of which did not change. Williamson was wearing a black sweatshirt with a white vest underneath, sweatpants, and did not have a baseball cap on. At this time I observed another individual who exited the store that matched the description of the suspect. The male who exited the Five Guys did not want to answer questions at first but eventually showed me that he was a Doordash employee. While speaking with the Doordash employee Williamson left the store without me observing him.

I then responded back to Target to get the video footage. Through the footage and loss prevention employee Nelson Ortega statements I was able to confirm that Williamson was the suspect who shoplifted an Apple watch valued at \$279.99. While watching the video I observed Williamson and Green walk over to the electronics department. Williamson observes an Apple watch that was left out on the cash register table unattended. Williamson then grabs the Apple watch places it in his sweatshirt and leaves the store without paying. I then observe Williamson and Green approach a parked vehicle in between Five Guys and Target bearing NJ registration U10MNY. It appeared they might have placed the Apple watch in the vehicle at that time. Dispatch then notified me that an employee at Five Guys found a brand new Apple watch under a sign near the cash register. The watch was still in the box and unopened. At this time the employees were not able to save the video, I provided them with my e-mail for the video surveillance when a manager was able to send it. Target provided me with a receipt for the Apple watch as well as video surveillance of the entire incident both items were logged into evidence. I brought back the Apple watch that was found by the Five Guy employee to Ortega.

On 12/12/2021 at approximately 18:37 hours, I was dispatched to 5000 Hadley Center Drive (Target) for the report of a theft.

Upon arrival I met with Loss Prevention Officer Nelson Ortega, who informed me of multiple thefts committed by an employee, Jelani Green totaling \$878.09.

Ortega advised that Green was currently in the main office being confronted over the thefts and formally let go from his job. Ortega also informed us that Green had signed an admission statement for Target admitting to the thefts. Ortega stated that he had caught Green stealing merchandise from the store on 4 different occasions, specifically on 12/04/2021, 12/05/2021, 12/06/2021 and 12/08/2021. Ortega informed me that Green would remove items from the sales floor and from the stock room. He would then proceed to scan the items as if to make a transaction, and then change the price to \$0.00. Ortega was able to provide a copy of his investigative report which documented the thefts.

Ortega relayed that on 12/04/2021, while working his shift, Green scanned Pokemon cards, A Pokemon Card Binder, and Airpods zeroing out there costs and placed them aside for himself. At the conclusion of his shift he took the items and proceeded to leave the store with them. Ortega stated that this incident as well as the others, were all caught on security cameras. Ortega stated the total amount taken on this date was \$278.49

On 12/05/2021 Ortega stated that Green can be seen on camera removing Pokemon Cards and various Xbox games from their display's and scans them. He then never pays for the items and at the conclusion of his shift takes the items and leaves the store. Ortega stated the total amount for items taken on this date was \$281.33.

On 12/06/2021 Green seen on camera taking various items from the market, PC Games, and a filing cabinet. He scans the listed items and never makes payment for them. At the conclusion of his shift he leaves the store with the items. Ortega stated the total amount for items taken on this date was \$130.16.

On 12/08/2021 Green is seen on camera conducting transactions at a register. Green then never puts the cash received for payment into the register, keeping the cash for himself. Ortega stated the total amount taken on this date was \$234.02.

The total amount for all items and cash stolen across the 4 days totaled \$878.09.

Ortega brought us to Green's location where he was subsequently placed under arrest. I transported Green directly to HQ's while Ofc. Parada stayed with Ortega to get a taped statement (see Ofc . Parada BWC footage for statement).

Upon our arrival at HQ's Green was placed into the booking room to be processed. While at HQ's Green stated he would be willing to provide a voluntary taped statement on the thefts. Myself and Ofc. Parada conducted the statement which was recorded on our BWC's. Green was read his Miranda Rights and

indicated that he still wished to speak with us. Throughout the statement Green admitted to the thefts and was very forthcoming about what he had done. See BWC footage for exact statements. At the conclusion of the statement Green was placed back into the booking room where Green was booked, photographed, fingerprinted, and later released on multiple summons for the various thefts. For summons numbers see additional reports 21- 45954, 21-45955 and 21-45959 that were opened for the purpose of arrest reports. Additional reports also contain each individual property report for each incident.

For the incident on 12/04/2021 Green was issued summons S2021000403. Green was given his copy of his CJP form and provided with his court date.

The footage from Target was burned onto a CD and later entered into the BEAST evidence management system (FD-1). The copy of Ortega's investigative report and the Miranda Card were entered into evidence as well and tagged as FD-2.

On 12/14/21, I responded to 5000 Hadley Center Drive (Target) on a shoplifting report that occurred on 12/03/21.

Upon my arrival, I spoke with the store's loss prevention officer, Nelson Ortega, who stated that he needed to document a shoplifting that had occurred on 12/03/21. Ortega noted that the merchandise, \$295.35 worth of Red Bull Energy Drink, had been recovered when he had confronted the suspect as he was leaving the store. Ortega stated that at 19:33 hours on 12/03/21, a white male was observed attempting to leave the store with a shopping cart full of Red Bull packages.

The male had been seen by another loss prevention officer putting the Red Bull into the shopping cart and notified Ortega who decided to wait outside the store to see if the male would pay for it or not. Ortega also noted that the unidentified male appears to have stolen from this location in the past and with the same Red Bull merchandise.

Ortega then stated that the male, described as a white male in his late 20's, over 6'0 wearing a Yankees ball cap, grey jeans, dark colored sweatshirt and black shoes, was seen pushing the shopping cart bypassing the point of sales and walked right out the front vestibule. Ortega confronted him and identified himself as Target Security. When he stated this, the male is seen on the store video immediately giving up the shopping cart to Ortega and continuing on his way without saying a word to Ortega. Ortega noted that their policy does not allow any type of hands on detention. The male was observed getting into a red colored vehicle and leaving the area though the video did not make out the registration.

Ortega noted that the store would be signing complaints if and when a suspect was identified. Ortega was able to provide me with a cd copy of the store's video footage which was later tagged as evidence, entered into the evidence management system and placed into Evidence Locker #16.

On the above date and time I responded to the area of Target located on Hadley Center Drive for a motor vehicle accident. Upon my arrival I spoke to the caller, Cassandra Ford who stated that the other vehicle involved fled the scene. Ford stated that the incident began on Stelton Road when a gold colored Honda CR-V merged into her lane almost causing an accident. Ford proceeded to follow said vehicle into the parking lot of Target Department Store (5000 Hadley Center Drive). Ford stated that she was following the other vehicle to confront the driver of his reckless behavior that almost caused an accident. Ford stated the Honda pulled into a parking space and she backed into a parking space across from him.

Ford described the driver of the Honda as a very young oriental male. Ford stated when she saw the driver step out of his vehicle she asked him to apologize for his actions at which time the male answered by calling her a "Nigger". Ford stated the two argued until the driver of the Honda got back into his vehicle and reversed it into her vehicle. At this time Ford began to take pictures of said male and the vehicle which appeared to have angered the male even more causing the male to get out of his vehicle and confront Ford. Ford stated the male pushed her into her vehicle and attempted to strike her with a closed fist but missed several times. Ford stated the male then proceeded to get back into his car and it appeared as if he was leaving until he made a "K" turn and struck her vehicle head on. Ford stated she had to move out the way in order to not get hit by the Honda. The gold color Honda fled the scene heading towards the Bank of America.

While investigating this incident I was able to obtain video surveillance from Target security and a copy was given to Det. Hlavka. I observed the suspect drive the Honda at Ford, as she stood outside the drivers side of her vehicle. She had to move out of the way from being struck by the vehicle. The suspect vehicle drove into Ford's vehicle. Ford was asked to come to headquarters and she provided a taped statement to Det. Hlavka. The pictures that Ford captured on her phone were uploaded to this report. After viewing the images of the vehicle provided by Ford I observed that the vehicle did not have a registration plate but instead had a TUF FLAT Shield Cruiser Accessories 76100 which is a license plate frame cover.

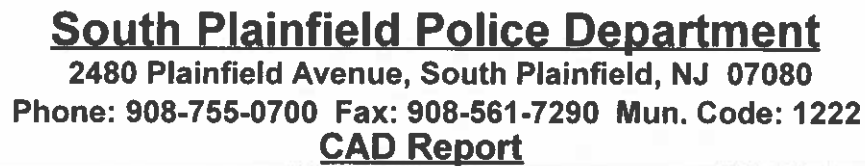

I was dispatched to Target, located at 5000 Hadley Center Drive, for the report of a known shoplifter, currently in the store. Upon my arrival at the store, I spoke with Target's Loss Prevention Officer, Nelson Ortega. I was advised by Ortega that they were currently watching a female, later identified as Soje Rivera, who is known to shoplift from their store. Ortega stated the female currently has several open cases with them for shoplifting.

At this time, I observed Rivera on video surveillance walking up and down different aisles in the beauty & medication section. Rivera was taking items off the shelf and placing them in her shopping cart. Rivera then covered the items with a jacket or pieces of clothing. This went on for about 10 minutes before Rivera was observed walking towards the exit door near the Pharmacy. It was obvious at this point that Rivera was attempting to leave the store without giving proper payment for the items she was concealing in her shopping cart.

With the assistance of Ortega, Rivera was confronted and stopped outside of Target near the parking lot. Due to me observing the following criminal violation in person, Rivera was placed under arrest for shoplifting. Rivera was placed in the rear of marked patrol unit # 59, then transported to headquarters by Officer DeBiase, to begin the booking process. The stolen items which are beauty product, over the counter medications, and clothing which were later found to total \$826.57.

All items were returned to Ortega on scene. A property form was completed to document the items taken which were subsequently returned to the store. While still on scene gathering information on the total price of the items stolen. Ortega indicated that there was a second female currently being observed, who was concealing items in a bag. I remained on scene until this second female, who doesn't appear to be involved with Rivera was subsequently arrested, see report # 22-04682 for further information.

At headquarters, I was advised by Sgt. Bullock that drug paraphernalia was located on her Rivera. Dispatcher/Matron Samoya, who is a female, discovered that Rivera was concealing the following items underneath her bra:

- 1) One white waxy fold, labeled in red "Chicken Waffles", with suspected heroin residue.
- 2) One broke glass pipe with "Chore Boy at the tip, commonly used to inhale crack cocaine.
- 2) One use hypodermic needle.

A photograph of the items located on Rivera were taken and attached to this report. The hypodermic needle and glass crack pipe were properly disposed of. The white waxy fold containing suspected heroin was marked as evidence JO-2, entered into the BEAST management system, and placed in evidence locker #16.

While I was at Target, located at 5000 Hadley Center Drive, I was investigating a shoplifting which resulting in an arrest, see case #22-04675. During the course of this investigation, Target's Lost Prevention Officer, Nelson Ortega advised me one of his employees is currently observing a female on video surveillance concealing items in a handbag. The female was later identified as Alexandra Tyrrell, upon her subsequent arrest.

I observed Tyrrell on video surveillance, concealing items either in a brown handbag or green hangbag. Ortega indicated Tyrrell was also observed walking into the women's restroom, wearing a black shirt and normal fitting shoes then walked out of the bathroom wearing a completely different outfit. Ortega believes that Tyrrell went into the female's restroom, changed her clothes with previously concealed clothes in her handbag.

For the next ten minutes I observed Tyrrell walking up and down several aisles, while continuing to conceal items in these handbags. Tyrrell began walking towards the exit near the Pharmacy, in an attempted to flee the store without giving payment.

As Tyrrell began exiting the store, she was confronted by Ortega and I. Due to me observing Tyrrell not only concealing items in the hand bags, but observing her attempted to exit the store without paying, she was placed under arrest for shoplifting.

Tyrrell was handcuffed and placed in the rear of marked patrol unit # 52. While arresting Tyrrell, Ortega indicated several items in the cart didn't belong to Target. Ortega indicated that several items had Marshall's tags on them, to include security tags which were still attached the items. Without being asked Tyrrell stated that the Marshall items belong to her, and she purchased them prior to entering Target.

When asked if Tyrrell could provide receipt for these items, she indicated "No". It was obvious these items were most likely stolen from Marshall's, but no report has been filed at this time. Ortega also noticed Tyrrell was wearing clothes that she hadn't paid for. This included a sweater and pair of high heel shoes.

Ortega compiled a receipt of the items Tyrrell attempted to take without payment, resulting in a total of \$1,253.79. These items were beauty products, electronics, and groceries. These items were returned over on scene to Ortega. The sweater and high heels that Tyrrell was wearing were later returned. Ortega was later able to provide a copy of the video surveillance which was later marked as JO-1, entered into the BEAST system, and placed in evidence locker #16. Tyrrell was transported to headquarters in marked patrol unit # 52, to begin the booking process.
