The table below identifies the records that being denied in whole or in part as well as the legal basis for each denial, as is requested by N.J.S.A. 47:1A-6.

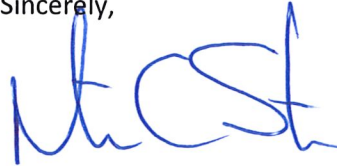
