When I arrived I observed a Nissan Pathfinder being driven on the track with 2 horses trotting along in front of the vehicle. The vehicle stopped when it came around to our side and Sam Captain was operating the vehicle. Sam is the head trainer at the DD Ranch. Sam said that he uses this method to run his horses in the morning. The horses I observed were far ahead of the vehicle and did not appear to be distressed or fearful. Their ears were up and neutral and their bodies appeared to be relaxed and just trotting along. While the vehicle was stopped the horses stopped and were casually grazing along the track. They resumed trotting when the vehicle approached them again. They again did not react fearfully but just moved off keeping their distance. I did not observe anything that appeared to be abusive or cruel.

I WAS AT THIS LOCATION WITH OFFICER KAVAFES FOLLOWING UP ON A CALF THAT WAS PREVIOUSLY STRUCK BY A CAR. WHILE CHECKING THE WELL BEING OF THAT CALF, I WAS ADVISED THAT THERE WERE HORSES ON THE OTHER SIDE OF THE FARM IN THE BOARDING AREA THAT WERE NOT BEING CARED FOR. THE COMPLAINANT, FRANK DELBORRELLO OWNS THE DOUBLE D RANCH. I WENT TO THE BOARDING SIDE OF THE FARM AND VISUALLY EXAMINED THE 6 HORSES OWNED BY TINA DACE. ALL OF THE HORSES NEEDED HOOF CARE. MOST OF THEM HAD ACCEPTABLE BODY MASS SCORES (SOME LOW BUT NOT CRITICAL) WITH THE EXCEPTION OF A MARE NAMED KARMA. HER BODY MASS SCORE WAS VERY LOW WITH PELVIC POINTS PROTRUDING SHARPLY. FATTY DEPOSITS SUBSTANTIALLY DEPLETED AT THE BASE OF THE TAIL, RIBS PROTRUDING SUBSTANTIALLY AND A WOUND THAT WAS FESTERING ON THE HORSES RIGHT REAR LOWER LEG. 3 OF THE HORSES WERE IN STALLS AND THE STALLS WERE VERY DIRTY. FECAL MATTER WAS DEEP AND THE HORSES WERE FILTHY WITH DIRT AND FECES CAKED ON THEIR BODIES. THERE WAS NO FOOD OR WATER IN ANY OF THE STALLS. THE OTHER 3 HORSES WERE IN A Paddock IN THE REAR OF THE PROPERTY. THOSE HORSES DID NOT HAVE WATER AND THERE WAS NO FOOD PRESENT IN THE Paddock. ALL OF THESE HORSES NEED HOOF CARE WITH ONE LARGE CHESTNUT HORSE HAVING VERY BAD FEET. I PLACED A CALL VIA CELL PHONE TO THE OWNER TINA DACE, I ADVISED TINA THAT I WAS AT THE FARM AND WAS VERY CONCERNED ABOUT THE CONDITION OF THE HORSES. TINA SAID SHE WOULD MEET ME THERE SHORTLY.

I MET TINA AT THE FARM AT APPROXIMATELY 1400 HOURS. TINA KEPT BLAMING EVERYONE ELSE FOR THE CONDITION OF THE HORSE SAYING THAT FRANK AND THE OTHER PEOPLE AT THE FARM WERE BLOCKING HER FROM CARING FOR HER HORSES. I KEPT ASKING HER WHY SHE HADNT CALLED THE POLICE DURING ALL OF THESE CONFRONTATIONS. SHE DIDNT HAVE AN ANSWER. I TOLD TINA THAT SHE WAS RESPONSIBLE FOR THE HORSES AND THAT THERE SHOULD BE NOTHING STANDING IN THE WAY OF HER PROPERLY CARING FOR THEM. TINA SAID SHE WAS MOVING THE HORSES AT THE END OF THE MONTH. I ADVISED HER THAT SHE IS REQUIRED BY STATE LAW TO HAVE UP TO DATE "COGGINS" TESTS FOR ALL OF HER HORSES IN ORDER TO MOVE THEM. SHE SAID SHE KNEW THAT AND BELIEVED THAT SHE DID HAVE THEM. I TOLD HER THAT I NEEDED A VETS REPORT ON KARMA, ALONG WITH PROOF OF THE COGGINS TESTS. I ALSO NEEDED THE ADDRESS OF WHERE THE HORSES WERE BEING MOVED TO. I TOLD HER THAT THERE NEEDS TO BE IMMEDIATE CHANGES IN THE HORSES CARE WITH PROPER FEEDING, CLEAN WATER AVAILABLE AT ALL TIMES, AND THE STALLS TO BE CLEANED.
