Witnesses advised having observed the victim lose consciousness, victim's brother [REDACTED] advised the victim was unconscious for approximately 5 minutes, during which time, it appeared the victim was seizing. Brielle First Aid and Medics transported the victim to Brick Hospital for evaluation and treatment.
