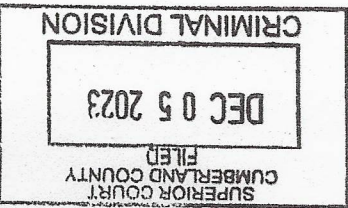

WAIVER OF FORMAL EXTRADITION

I, **RICHARD TOELK** (DOB: June 26, 1968), having been detained in the State of New Jersey, County of Cumberland, on charges arising from the State of New York, acknowledge that I have been informed of the charges against me, to wit: **Grand Larceny**, and that the State of New York has demanded my surrender.

It has further been explained to me that I have the right to demand a warrant of extradition, and that I have the right to test in this court the legality of my detention by filing a writ of *Habeas Corpus*. I also have the right to the assistance of legal counsel.

Having had these rights explained to me, and understanding each, I do freely and voluntarily waive each and every one of them, and I am willing to submit to the custody of the State of New York without any further legal proceedings in the State of New Jersey.

I have reviewed this document fully, and I understand that by signing below I am waiving my rights as indicated herein. My signature does not, however, signify any admission of guilt.

ORDER

This Court having advised the detainee of his or her rights under the uniform criminal extradition law and having received the detainee's Waiver of Formal Extradition, it is therefore **ORDERED** that the detaining agency having the detainee in custody shall deliver the detainee into the custody of any authorized agent of the State of New York without unreasonable delay and no later than thirty (30) days from the date detainee is eligible for release from his or her current place of incarceration. It is hereby ordered that should the inmate not be picked up directly from his or her current incarcerating institution that the fugitive be held in the custody of the Cumberland County Jail during those thirty (30) days pursuant to N.J.S.A. 2A: 160-20 and N.J.S.A. 2A:160-23. Failure to comply with this order may be considered a violation of law pursuant to N.J.S.A. 2A: 160-19.

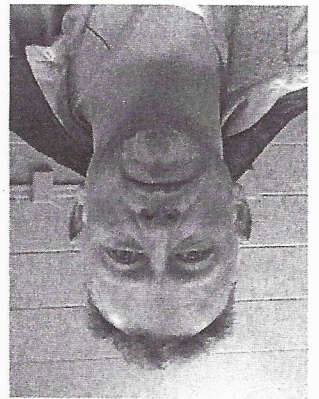

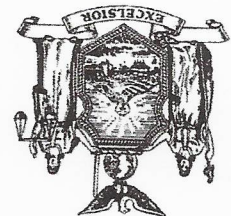

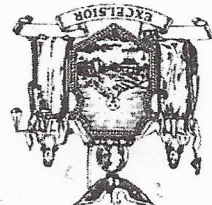
