The Ewing Township Clerk's Office received your Open Public Records Act (OPRA) request on May 30, 2023. The official Records Custodian, Kim Macellaro, received your OPRA request on May 30, 2023. As such, the seven (7) business day deadline to respond to your request is June 8, 2023. This response to your request is being provided to you on the 6th business day after the custodian's receipt of said request.

Your OPRA requested the following:

1. Vacant Property List, unpaid property taxes from 2019 to the present, and list of tax liens from 2018 to present.

Please see the responses from the Construction Department and the Tax Office.

This response is being provided to you in its entirety with any necessary redactions according to N.J.S.A. 47:1A-1.1. This is being transmitted to you via e-mail as per your request. Pursuant to N.J.S.A. 47:1A-5.b., the cost associated with this request is zero.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law; you have a right to challenge the decision by the Ewing Township Clerk's Office to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
