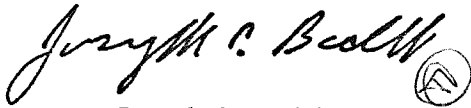

- # of Units (if multi family, mixed use, or has multiple commercial/industrial tenants)

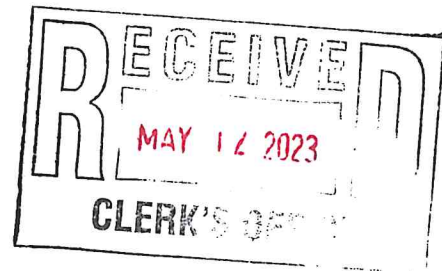
