The Borough of Glassboro Records Custodian received your records request pursuant to the Open Public Records Act (OPRA) and the New Jersey common law right of access on January 4, 2021. Accordingly, the initial seven (7) business day deadline to respond to your request under OPRA is January 13, 2022. This response is being provided on the seventh day after receipt of your request.

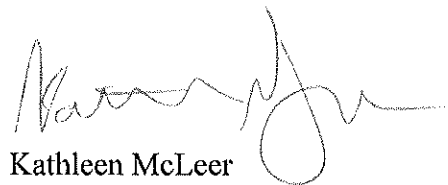

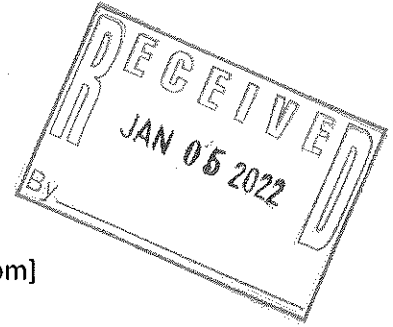
