3. Addresses of all residential properties (Property Class 2) that have had a notice of abatement issued, specifically from 1/1/2022 to the present day *Prochamps*

4. Addresses of all residential properties (Property Class 2) that are fire damaged, specifically from 1/1/2022 to the present day *none*
5. Addresses of all residential properties with delinquent property taxes, specifically for the past 2 quarters
6. Addresses of all residential properties with delinquent water and sewer bills, specifically for the past 2 quarters
7. Addresses of all residential properties with an active municipal owned lien
8. Addresses of all residential properties that have had a code enforcement complaint opened for high grass and/or junk/debris, specifically from 1/1/2022 to the present day *attached*
9. Addresses of all residential properties that have had a landlord file for eviction, specifically from 1/1/2022 to the present day *none*

10. Addresses of all residential properties for which a Lis Pendens Notice has been filed, specifically from 1/1/2022 to the present day
