Please be advised that my office received your request for public records pursuant to the New Jersey Open Public Records Act (NJ-OPRA), *N.J.S.A. 47:1A-1 et seq.*

Upon review of files kept and maintained by the Borough of Roselle Park, twenty-nine (29) letter sized pages and five (5) legal sized paper were found to exist pursuant to your request for: "Public Records requested: 1. Addresses of all residential properties (Property Class) that are marked as vacant and/or abandoned. 2. Addresses of all residential properties (Property Class 2) that are marked as condemned. 3. Addresses of all residential properties (Property Class 2) that have had a notice of abatement issued, specifically from 1/1/2022 to the present day. 4. Addresses of all residential properties (Property Class 2) that are fire damaged, specifically from 1/1/2022 to the present day. 5. Addresses of all residential properties with delinquent property taxes, specifically for the past 2 quarters. 6. Addresses of all residential properties with delinquent water and sewer bills, specifically for the last 2 quarters. 7. Addresses of all residential properties with an active municipal owned lien. 8. Addresses of all residential properties that have had a code enforcement complaint opened for high grass and/or junk/ debris, specifically from 1/1/2022 to the present day."

You will find that certain information is redacted and not publicly disclosed. NJ-OPRA and, more generally, New Jersey State law provides for specific exemptions that require certain information to be withheld from public disclosure. These specific exemptions are outlined in *N.J.S.A. 47:1A-1.1*. **In the case of your request, each redacted item is being withheld as it is personally identifying information which may include unlisted telephone numbers, social security numbers, or personal e-mail addresses.** Other than the redactions outlined herein, all other information has been provided in accordance with the law.

Please be advised that the records hereinafter provided, if any, represent the full and complete response to your captioned request by the Borough of Roselle Park. Any records requested that have not been provided herein have not been found to exist.
