3. A list of property addresses that have received any code violations since the beginning of the year.

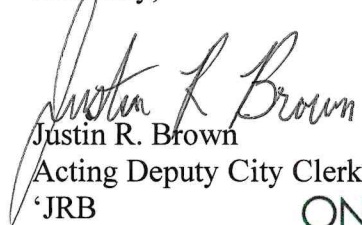
For item number 1, Per the Tax Collector's Office there is not a property addresses that have an unpaid property tax bill list on file.
