Re: Open Public Records Act/Common Law Records Request

Dear Mr. Anapete:

The Borough of Glassboro Records Custodian received your records request pursuant to the Open Public Records Act (OPRA), dated January 25, 2023, on January 26, 2023. Accordingly, the initial seven (7) business day deadline to respond to your request under OPRA was February 6, 2023. By correspondence dated February 6, 2022, we requested a seven (7) business day extension, until February 15, 2022, to further process your request. We responded to your request on February 15, 2023, at which time we advised you that a preliminary search of our available records had identified files for "Lundy Hall," a building that has since been demolished, and an ongoing file for "50 South Academy, LLC" for redevelopment. We further requested that you clarify your request by identifying the specific types of records requested, the applicable time frames, and the type of "correspondence" which you seek. You clarified your request by email dated February 15, 2023 as follows:

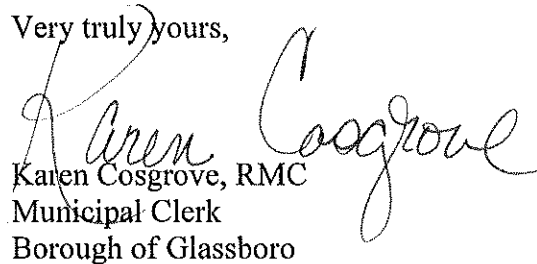

We provided our initial supplemental response to your clarified request on February 27, 2023, and requested an extension of time, until March 17, 2023, to further process the remaining parts of your request.

A search of our available records has identified no applications to the Borough, Planning Board or Zoning Board regarding the plans for redevelopment responsive to your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Borough of Glassboro to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
