WHEREAS, the Township of Brick and the Brick Township Board of Education have applied to the Brick Township Planning Board for capital project approval pursuant to N.J.S.A. 40:55D-31; and

WHEREAS, the Planning Board reviewed the proposal of the Township and Board of Education at its meeting held on October 6, 1993; and

WHEREAS, the Board makes the following factual findings and findings of law:

1. This property is designated as Lot 12, Block 701.39 on the Municipal Tax Map.

2. The Township and Board of Education propose to maintain a joint fueling facility at the site to provide fuel for vehicles operated by the Township and Board of Education. Redundant fueling facilities formerly utilized by each body will be closed in accordance with regulations of the Department of Environmental Protection and Energy.

3. The Board finds that the proposed project is consistent with the municipal zoning ordinance and master plan and will not
