ORDINANCE 728-92

ORDINANCE OF THE TOWNSHIP OF BRICK, COUNTY
OF OCEAN, STATE OF NEW JERSEY AMENDING AND
SUPPLEMENTING CHAPTER 121 ENTITLED
"CONSTRUCTION CODES, UNIFORM" TO ADD
SECTION 121-3 "BUILDERS RESPONSIBILITY."

BE IT ORDAINED by the Township Council of the Township of
Brick, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 121-3 of the Brick Township Code is
hereby enacted as follows:

121-3. Builders Responsibility

- A. Prior to any permit being issued for construction of
any kind, the person or entity applying for the permit
shall, as a prerequisite to the issuance of that permit,
provide the Construction Official with written
documentation setting forth the person's or entity's
proposal to dispose of all construction debris resulting
from the construction for which the permit is being
issued.
- B. Prior to the issuance of a Certificate of Occupancy, the
person or entity performing the construction shall
provide the Construction Official with written
documentation setting forth that the person or entity has
complied with the proposal to dispose all of the
construction debris.

SECTION 2. All Ordinances or parts of Ordinances
inconsistent herewith are repealed.

SECTION 3. If any section, subsection, sentence, clause,
phrase or portion of this Ordinance is for any reason held invalid or
unconstitutional by a Court of competent jurisdiction, such portion
shall be deemed a separate, distinct and independent provision, and
such holding shall not affect the validity of the remaining portions
hereof.

SECTION 4. This Ordinance shall take effect in the manner as
prescribed by law.
