R E S O L U T I O N R-32-78

Case #1069-Plan Dated January 12, 1978, Latest Revision Date May 3, 1978
WHEREAS, application has been made by Brick Township

Board of Education for final approval of a minor subdivision
and consolidation of Block 1386 Lots 24 & 26 Block 1211 Lot 2
as shown on the Tax Map of the Township of Brick and divided
into 1 Lot; to be designated as follows:

Block 1211, Lot 2

And the subdivision committee of the Planning Board
of the Township of Brick having recommended that said subdivision
be approved.

And the Board having considered the testimony of all
proponents and opponents thereof and the exhibits produced
and the Board having made the following factual findings:

1. That the object of the subdivision is to add
8.88 acres of Lot 24, Block 1386 to 19.75 acres of Lot 26 Block
1386, 0.15 acres of Lot 4 Block 1210, and Lot 17 in Block 1210
which is under condemnation. All of said tracts which will be
combined with Lot 2, Block 1211, which is under contract, to
make one parcel for the Brick Township Board of Education.
2. The owners of Lot 24, the property being subdivided,
are Jack and Manny Berkowitz and J. Shirovsky, of Lakewood, New
Jersey. The applicant is the Brick Township Board of Education
who is the equitable owner of Lot 2 Block 1211, Lot 17 Block 1210,
0.15 acres of Lot 4 in Block 1210 and 19.75 acres of Lot 26
Block 1386.

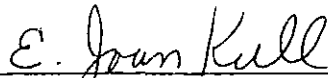
