TAKE NOTICE that you have been found to be in violation of the State Uniform Construction Code Act and Regulations promulgated thereunder (N.J.A.C. 5:23-2.30 and 2.31) in that:
NO PERMIT FOR ROOFING AND WINDOW

Chapter: 5:23-2.5 Construction Permits

(a) Rules concerning when a permit is required:

1. It shall be unlawful to construct, enlarge, alter or demolish a structure requiring greater strength, exit way or sanitary provisions; or to install or alter any equipment for which provision is made or the installation of which is regulated by the regulations, without first filing an application with the construction official in writing and obtaining the required permit therefor.

You are hereby ordered to terminate the said violations on or before 6/5/90.
The owner and agent/contractor bear joint responsibility for bringing about compliance. No Certificate of Occupancy or Approval will be issued unless the said violations are corrected.

- ☐ Failure to comply with this Order will subject you to a penalty of \$ 500.00 per day.
- ☐ You are hereby ordered to pay a penalty in the amount of \$ 500.00 for each violation for a total penalty of \$ 500.00. Each day that any of the said violations remain outstanding after _____ shall result in an additional penalty of \$ 500.00 per day.

If you wish to contest the validity of the above action, in accord with N.J.A.C. 5:23-2.35 et. seq., you may request a hearing before the Construction Board of Appeals of the County of Ocean of Toms River, within 20 business days of receipt of these Orders. The Application to the Construction Board of Appeals may be used for this purpose.

Your application for appeal must be in writing, setting forth your address and name, the address of the building or site in question, the permit number, the specific sections of the Regulations in question, and the extent and nature of your reliance on the Regulations and, if necessary, a brief statement setting forth your position and the nature of the relief sought by you. You may also append any documents that you consider useful.

The fee for an appeal is \$ 50.00 to be forwarded with your application to the Board of Appeals office at _____.
