WHEREAS, the Brick Township Planning Board granted Preliminary and Final Site Plan approval with variances and waivers to COSTCO WHOLESALE, Block 1170, Lot 5, 6, 6.01, 6.02, 7 & 8 , as designated on the official Tax Map of the Township of Brick, by Resolution R-79-01 adopted on August 8, 2001; and

WHEREAS, the Brick Township Planning Board granted Amended Final Site Plan Approval by Resolution R-85-01, dated September 26, 2001;

WHEREAS, the Brick Township Planning Board granted a first one-year extension of approval by Resolution R-55-03 dated September 10, 2003;

WHEREAS, the applicant has requested that the Planning Board grant a second one-year extension of this approval; and

WHEREAS, the Planning Board has reviewed the efforts made by the developer to obtain all necessary other legal permits so as to effectuate the preliminary and final site plan approval with variances and waivers granted by Resolution R-79-01 and Amended Final Site Plan approval granted by Resolution R-85-01; and first extension granted by R-55-03, and has determined from that history that the statutory provisions of N.J.S.A. 40:55D-49(c) are met and that therefore a second one-year extension granted herein is appropriate.

NOW, THEREFORE, be it resolved by the Planning Board of the Township of Brick, on this 13th day of October, 2004, that the application of COSTCO WHOLESALE, for a second one-year extension of Preliminary and Final Site Plan approval with variances and waivers be granted, subject to the following conditions:

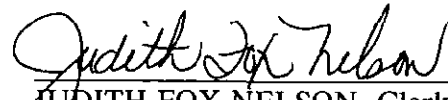
