On the above date and time, I, Cpl. Pasieka was on patrol, working on a prostitution sting case. It was at that time that I was utilizing a department-issued cell phone ([REDACTED]) to make the contact. Before that, I was browsing a known website for prostitution (Skipthegames.com). It should be noted that I have made contacts, met with, and arrested individuals for soliciting prostitution on this site before. I then made text contact with the defendant (Lori Hawk). A copy of the conversation was copied and printed for evidence by Detective Sundermann. This will be attached to the report. She reached the phone number [REDACTED]. She told me her name was Emma. On her ad she offered services for several sexual acts. This includes times and prices. In the text, she explained that she charged \$300.00 for the sexual acts. She elaborated that the \$300.00 was for the services she offered in the ad. She was then spoken with on the department cell phone (this was recorded on the body camera). She said that she would be wearing a sweatshirt and leggings. She also stated that she would be arriving in a silver SUV. It should be noted that she was given the address to meet at 236 Franklin ave apartment 1, for the meetup. She stated that she would only come to a house and not a motel. She then texted that she was on her way. Detective Sundermann, who was working in a plain clothes capacity awaited in the house. Ptl, Dinklage and Ptl.Zilenas stood by for the arrest. Hawk did send a picture also of what she looked like. We were able to identify her from picture although it was an older picture. She was told to meet on the Barnegat side of the house, which she did. She came to the door, identified an arrest without incident. See Sundermann's arrest report.
