ON THE ABOVE DATE AND TIME, I PTL. DINKLAGE WAS WORKING ON A PROSTITUTION DETAIL LOCATED AT 236 FRANKLIN AVE. THE WEBSITE THE PROSTITUTION AD WAS FOUND ON SKIPTHEGAMES.COM, A KNOWN ESCORT WEBSITE. IT SHOULD BE KNOWN THAT MULTIPLE ARRESTS HAVE BEEN MADE FROM PRIOR PROSTITUTION CASES WITHIN THIS JURISDICTION.

WHILE ON THE WEBSITE, I LOCATED "THROAT GOAT", WHO WAS LATER IDENTIFIED AS NAOMI VEGA, PER A NEW YORK DRIVER'S LICENSE. IT SHOULD BE NOTED THAT THE DRIVER'S LICENSE INDICATED VEGA AS A MALE, BUT IDENTIFIED AS A FEMALE. I USED THE SEASIDE HEIGHTS DETECTIVE CELL PHONE TO INITIATE CONTACT WITH VEGA VIA TEXT MESSAGES. WITHIN THESE MESSAGES, VEGA OFFERED ORAL SEX AND INTERCOURSE FOR AN AGREED AMOUNT OF \$460. VEGA WAS TO MEET AT 236 FRANKLIN AVE.

AT APPROXIMATELY 20:15 HRS, VEGA ARRIVED AT THE 236 FRANKLIN AVE AND KNOCKED ON THE DOOR OF THE APARTMENT. I ANSWERED THE DOOR, AND VEGA LOOKED PERPLEXED. I BROUGHT VEGA INSIDE, PLACED HANCUFFS ON, AND ADVISED HE WAS UNDER ARREST. I THEN SEARCHED VEGA AND HANDBAG INCIDENT TO ARREST, YIELDING NEGATIVE RESULTS FOR ANYTHING ILLEGAL. VEGA WAS ESCORTED AND PLACED IN THE BACK OF PATROL CAR 3. THEN TRANSPORTED TO POLICE HEADQUARTERS TO BE BOOKED AND PROCESSED. AFTER THE BOOKING PROCESS, VEGA WAS RELEASED ON A COMPLAINT SUMMONS.

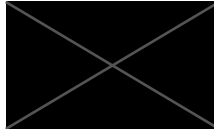
