While on patrol, I was conducting a prostitution sting on the website "Skip the Games". It should be noted that this site is known for the promotion of prostitution, and I have made several arrests from this website recently. On 2/26/26, I answered a Ad posted by a female going by "Nikki". She was later positively identified as Jessica Erwin. I then spoke with her on and off for several days about meeting up. She then offered sexual favors for \$650.00. We then made the arrangements to meet at 236 Franklin Ave. I spoke with her on the phone at [REDACTED]. It should be noted that she did send a current photograph of herself while texting me. I was able to confirm that it was her on the Skip the Games Ad she posted. I then exited a LYFT vehicle and walked to the address. She then knocked on the door, and Det Wasilick opened the door and arrested her. See Wasilick report.

On 03/05/2026, Cpl. Pasieka and I, Det. Wasilick, began an undercover detail in reference to a subject promoting prostitution on a website identified as Skipthegames.eu. It should be noted that this website is known for promoting prostitution and the Seaside Heights Police Department has made several arrests from this website this year and in 2025.

On 02/26/2026, Cpl. Pasieka had been utilizing a Seaside Heights Detective Bureau departmental cell phone in an under cover capacity and began conversing via cell phone ([REDACTED]) with a subject from the website with a female labeled "Nikki".

This female texted Cpl. Pasieka offering sexual favors for \$650.00 including a massage, blowjob, and sex.

The female, whom was later identified as (Jessica Erwin) had agreed to meet Cpl. Pasieka at 236 Franklin Avenue for money exchanged for sexual acts. I then traveled to the prearranged meet location of 236 Franklin Avenue while accompanied by a uniform officer Ptl. Dinklage.

Once the female arrived at 236 Franklin Avenue, she exited the vehicle and flicked a cigarette onto the ground and approached the front door. I then opened the front door to let Ms. Erwin in, I then Identified myself as a Police Officer and advised Ms. Erwin she is under arrest.

Ptl. Dinklage then placed handcuffs on Ms. Erwin, where she was searched, and then transported to the Seaside Heights Police Department where she was booked and processed, It should be noted while Cpl. Pasieka was searching Ms. Erwin property he found one empty wax fold with "Mac" stamped on it in blue ink. With his training and experience he knows that wax folds contain suspect heroin.

Ms. Erwin was later released on a summons to appear on court. She was charged (2c:34-1B8) Prostitution, (2c:36-2) Drug paraphernalia, and (118-2) Littering.

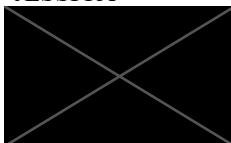
