On the above date and time, I, Cpl. Pasieka was working a prostitution detail using the website, "Skip the Games". It should be noted that I have made several arrests for prostitution stemming from the website. This website is also known for the promotion of prostitution. I then responded to an AD from a female using the name of "Grace". Her Ad stated that she charged \$200.00 and listed all the sexual activities that she offered (see Ad attached to the report). I then spoke with the female who gave me the name of Grace. She did confirm that the site I spoke with her on was hers. It should be noted that her site heading was "Discreet and Eager to please." This showed a picture of breasts with twenty-dollar bills on them. She then showed me a picture of her face. After speaking with her via text messages, a price of \$250.00 was agreed for her to come to the address of 236 Franklin Avenue. I then maintained a conversation with her on her way. She told me she was arriving, which I was able to observe her pulling up in a Black Kia Wagon NJ registration A47VMP. I told her to come to the Franklin Avenue side of the house. She then exited the vehicle and was wearing black leggings with a pink sweatshirt. She texted and stated she arrived. I was able to identify the female from the picture she sent to me. She was then placed under arrest without incident. She was then transported to the Seaside Heights Police Department. At headquarters, she was identified as Danielle Dudek. She was found to have no warrants and was charged with prostitution on a complaint summons and was later released.

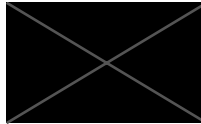
