Supplement

While on patrol, I Cpl. Pasieka was conducting a prostitution detail. At that time, I was searching the website "Skip the Games". This site is known for prostitution, where I have made several arrests from.

I then contacted an Ad on the site on 3/4/2026 with the listed number [REDACTED] See attached text messages). Throughout the chat, she offered sexual favors in exchange for monetary rates while speaking with her for two days. We finally agreed to meet at 236 Franklin Avenue for a total of \$450.00. She then maintained text contact as she was leaving and making her way to the location. When she arrived in a black Minivan, she texted that she was at the house. When she exited the Minivan, I was able to make a positive ID of the female from the photographs posted on her site. She was later identified as Jaquiline Kane.

Once she walked to the door, Officer Dinklage opened the door and placed her under arrest without incident. A search incident to arrest yielded 17 empty wax folds marked "Mac" in blue ink and two glass crack pipes with residue. These items were located on her person in her jacket pockets.

Ms. Kane was then transported to police headquarters, where she was booked and searched by another female, Officer Selert from the Seaside Park Police Department, with negative results. Ms. Kane was also wanted out of the Atlantic County Sheriffs Department (no bail NCIC warrant), Toms River Municipal Court (2,000.00 ACS), and Hammonton Municipal Court (\$1,000.00 ACS).

After being booked and processed, Ms. Kane was charged with prostitution (2C:34-1B(8)) and possession of drug paraphernalia (2C:36-2A). The paraphernalia was placed into an evidence bag and dropped in the evidence locker the same night. She was then transported to the Ocean County Jail on my complaint warrant and other outstanding warrants.
