Supplement

On the above date and time, I, Cpl. Pasieka was on patrol and working an undercover prostitution detail. To do so, I was using the website "Skip the Games". This site is known for promoting prostitution. It should be noted that I have made several prostitution arrests from this site in the past.

While utilizing the site, I made contact with a female, later identified as Megan Gallagher, utilizing the departmental cell phone. She posted an ad on the site and indicated her name was "Michelle". Her ad talked about sexually explicit acts, sexual in nature, as well as pricing for the acts. While speaking with her, she mentioned exchanging sexual acts for money with me for \$1070.00. I then saved and documented the pictures, ad, and text conversation to the case. After agreeing, she advised that she would utilize an UBER to the arranged location, 236 Franklin Avenue.

Later, upon her arrival, she was placed under arrest by Det. Bloomquist (plainclothes detective). See supplemental for further information. It should be noted that during the interaction with Det. Bloomquist, we were able to confirm Ms. Gallagher's identity by the ad, her driver's license, and the photo she sent. She also confirmed her location as she was arriving. She was subsequently charged with prostitution and released on a complaint summons.

On January 23, 2026, I, (Det. Cpl. Bloomquist) began working with Cpl. Pasieka in an undercover prostitution detail.

On January 23, 2026, Cpl. Pasieka began conversing through text message on a departmental cell phone with a female on a website identified as Skipthegames.eu. This website is known for promoting prostitution (Refer to Cpl. Pasieka's report). It should be noted that patrol and the detective bureau have made several arrests for prostitution in the past through this website.

On January 23, 2026, a female identified herself as "Michelle" had agreed to meet me at 236 Franklin Avenue for \$1070.00 in exchange for sexual intercourse (see attached text messages).

I then observed the female being dropped off by an Uber driver right in front of 236 Franklin Avenue. As she entered the apartment, I then greeted her as she walked through the door. Ptl. Dinklage and I then advised her that she was under arrest due to all the evidence obtained. She was then placed into handcuffs and transported to police headquarters for processing. She was later identified as Megan Gallagher.

Once processing was complete, she was then released on a complaint summons to appear in court on 2-10-2026.

BWC was not activated for this incident.

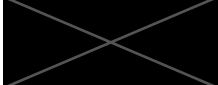
