On the above date and time, I was working an prostitution detail with Det. Cpl. Bloomquist and Ptl. Dinklage. I was using the "Skip the Games" website. This site is known for prostitution. It should be noted that several arrests have been made for prostitution from this site.

I was able to locate the female on the site under "Chocolate Fantasy". I started a conversation with the female (Shateara Bland). During the text and phone conversations, she spoke of exchanging sexual acts for money. This can be found in the text messages, along with a picture of her that she sent to me. We then made a time and place to meet at 236 Franklin Avenue. Communication was kept between the female and the police. She said that she was going to wear a brown one-piece body suit. She then arrived at the location in the outfit she said she was going to wear. She fit the description of the picture she sent. It should be noted that her phone number was the same phone number on the site.

She was arrested without incident.

Supplement

On 2-13-26, Cpl. Pasieka and I (Det. Cpl. Bloomquist) began an undercover detail in reference to a subject promoting prostitution on a website identified as Skipthegames.eu. It should be noted that this website is known for promoting prostitution and the Seaside Heights Police Department has made several arrests from this website this year as well as in 2025.

On 2-13-26, Cpl. Pasieka had been utilizing a Seaside Heights Detective Bureau departmental cell phone in an under cover capacity and began conserving via cell phone ([REDACTED]) with a subject from the website with a female labeled "Chocolate Fantasy."

This female texted Cpl. Pasieka "Full service sex covered." Cpl. Pasieka stated "OK, 200 for sex. Does that involve a blow job as well? Do you have a face picture at all?" The female replied, "Yes full service." The female then sent a photo of her face.

The female, whom was later identified as (Shateara Bland) had agreed to meet Cpl. Pasieka at 236 Franklin Avenue for money in exchange for sexual acts. Det. Wasilick and I then traveled to the prearranged meet location of 236 Franklin Avenue while accompanied by a uniform officer (Ptl. Dinklage).

Once the female arrived at 236 Franklin Avenue, she immediately knocked on the door which I then answered. She then walked into the apartment where I then identified myself as a police officer. Ptl. Dinklage and I then advised her that she was under arrest where she immediately said "I was just coming to give a massage."

She was then handcuffed, searched, and then transported to police headquarters for processing. Once processing was complete, she was charged with 2C:34-1B(8). She was then released on a complaint summons to appear in court on 3-03-2026.
