On the above date and time, I, Cpl. Pasieka was on patrol. It was at that time that I was working a prostitution sting detail. I was using the website "Skip the Games". This website is known to promote prostitution. I have made several arrests from this website before. At that time, I answered an ad from a female that posted later identified as Melanie Gibbons. I spoke with her via text messages. It is noted that during that time she did comment to exchange \$300.00 and a pack of Newport 100's for sex. Contact was kept with her while she was making her way to the motel. The address that was used was the Surfside Motel room 120. She then exited the back of the vehicle she arrived in and knocked on the door. Identification was made, and it was found that she was the female poster on the Ad. She was then placed into the back of a patrol vehicle and transported to the Seaside Heights Police Department, where she was booked, fingerprinted, and charged with prostitution. She was later released on a complaint summons.

On 04/30/2026, Cpl. Pasieka and I, Det. Wasilick, began an undercover detail in reference to a subject promoting prostitution on a website identified as skipthegames.eu. It should be noted that this website is known for promoting prostitution and the Seaside Heights Police Department has made several arrests from this website this year and in year 2025.

Cpl. Pasieka had been utilizing a Seaside Heights Detective Bureau Departmental cell phone in an under cover capacity and began conversating via cellphone ([REDACTED]) with a subject from the website with a female labeled "A head above the rest."

This female agreed in offering sexual favors for \$340.00 and a pack of cigarettes including a blowjob and sex.

The female, whom was later identified as (Melanie A. Gibbons) had agreed to meet Cpl. Pasieka at 200 Ocean Terrace (Surfside Motel) in room 120. I then traveled to the prearranged meet location while accompanied by a uniform officer Ptl. Faruolo.

Once the female arrived at the location, she exited the vehicle and approached the motel room door. I then opened the front door to let Ms. Gibbons in, I then Identified myself as a Police Officer and advised Ms. Gibbons she is under arrest for prostitution.

Ptl. Faruolo then placed handcuffs on Ms. Gibbons, where she was searched, and then transported to the Seaside Heights Police Department where she was booked and processed, later released on a summons to appear on court. She was charged with (2c:34-1.1B(1)).
