The Camden County Prosecutor's Office requested a reasonable extension of time until June 15, 2023 to review and respond to this request. This Office objects to this request as stated as it is overbroad and invalid because it fails specify the parties to whom the requested communications etc. either originated from or were received by. In addition, this Office objects to this request as stated because the terms "Sarah V" and "blue hair" and "green hair" are also overbroad and invalid. OPRA does not authorize a party to make a blanket request for "every document" or "all" documents. Bent v. Township of Stafford Police Dept., Custodian of Records, 381 N.J. Super. 30, 37, 39 (App. Div. 2005). The requestor's obligation is to specifically describe the document sought; the request may not be a broad, generic description of documents because the custodian is not required to speculate about what the requestor seeks, nor survey agency employees regarding the request. Bart v. Passaic Cnty. Pub. Hours. Agency, 406 N.J. Super. 445, 451-52 (App. Div. 2009).

Further, the request as submitted fails to name specifically identifiable government records and requires research beyond the scope of a custodian's duties pursuant to MAG Entertainment, LLC v. Division of Alcoholic Beverage Control, 375 N. J. Super. 534, 546 (App. Div. 2005), Bent v. Stafford Police Department, 381 N.J. Super. 30, 37 (App. Div. 2005), New Jersey Builders Association v. New Jersey Council on Affordable Housing, 390 N. J. Super. 166, 180 (App. Div. 2007), and Schuler v. Borough of Bloomsbury, GRC Complaint No. 2007-151 (February 2009). See also Toscano v. NJ Department of Labor, Division of Vocational Rehabilitation Services, GRC Complaint No. 2010-293 (March 2012), Elcavage v. West Milford Township (Passiac), GRC Complaint No. 2009-08 (April 2010), and Wolosky v. Township of Randolph (Morris), GRC Complaint No. 2010-244 (February 2012).

In addition, the Camden County Prosecutor's Office further objects to the request as stated in that the information being sought is law enforcement sensitive and covered by OPRA's exemptions for criminal investigatory records and/or inter-agency or intra-agency advisory communications.

Despite the above stated objections and without waiver of such, this Office has located the following document(s) responsive to your stated request. Please see attached Lindenwold Borough Police Department Incident Report (CAD).
